Mayor Catlin called the meeting to order at 6:00 p.m. Councilwoman Chamberlain led the Pledge of Allegiance. Invocation was led by Councilman Sands.

1. Fiscal Year 2026-2027 Administrative Budget – Ben Billingsley
Ben Billingsley shared a slide show presenting the administrative budget. Ben noted that the budget is one of the most important legislative actions that the Council makes every year. Ben provided an overview of how the budget is created and its timeline. Ben went over general fund revenue changes, employee wages and future positions, City expenses and funds, fleet management, and funding for future pavement preservation. Ben answered questions from the Council regarding road maintenance and budgeting for building permits. Ben identified revenue sources that may be at risk within the next fiscal year budget. Ben continued his presentation discussing the City's water, stormwater, and cemetery funds.



Ray Bence made a comment regarding water drainage. Mayor Catlin addressed the Toquerville City Well Being survey.

Mayor Catlin adjourned the meeting at 8:36pm.


