

NORTH LOGAN CITY PROPERTY TAX IMPACT SCHEDULE

[Note: Cache County Auditor has not yet published the Certified Tax Rate (CTR), Certified Rate Revenue (CRR), or Average Home Value (AHV); therefore, this Impact Schedule is using estimations until those values are published]

North Logan City will consider an increase to its property tax rate to generate an additional \$256,327. The following information is intended to provide decision makers and the public with an explanation of how the City's operations would be affected if the property tax rate remains the same.
