

RESOLUTION NO. R-2026-0005

A RESOLUTION BY THE OREM CITY COUNCIL
ACKNOWLEDGING COMPLIANCE WITH SEVERAL STATE
REQUIRED ACTIONS RELATED TO INCREASING THE
CITY'S PROPERTY TAX REVENUES AS PART OF THE
FISCAL YEAR 2026-2027 TENTATIVE BUDGET

WHEREAS on May 12, 2026, a separate item was placed on the Orem City Council meeting agenda notifying the public that the Chief Financial Officer of the City of Orem intended to state in the public meeting that the City of Orem's Fiscal Year 2026-2027 Tentative Budget includes a proposed property tax increase; and

WHEREAS the City Council acknowledges that the Chief Financial Officer of the City of Orem, as a separate agenda item, did make a statement in the May 12, 2026, public meeting that the Fiscal Year 2026-2027 Tentative Budget includes a proposed property tax increase; and

WHEREAS the City Council acknowledges that the Chief Financial Officer of the City of Orem presented to the Orem City Council, as a separate item on the agenda, in the same public meeting, a proposed property tax impact schedule separate from other budget documents, as defined in Section 59-2-924 of the Utah Code, that states that the City is considering levying a tax rate that exceeds the City's certified tax rate; lists the approximate dollar amount of and purpose for the additional tax revenue that would be generated by the proposed tax increase; shows the approximate percentage increase in tax revenue for the City based on the proposed tax rate increase; and that if the City proceeds with the proposed tax rate increase, the City will provide notice of and conduct a public hearing at which members of the public will have an opportunity to provide comments on the proposed tax rate increase; and

WHEREAS the City Council now directs the Chief Financial Officer of the City of Orem to present and make available to the public the proposed property tax impact schedule at each public hearing held prior to June 30 at which the City Council discusses the City's proposed tentative fund budget for the ensuing fiscal year for Fiscal Year 2026-2027.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OREM, UTAH, as follows:

1. The City Council hereby acknowledges that all of the actions stated above did occur in relation to the May 12, 2026, Orem City public council meeting.
