ADOPTING 2026-2027 FISCAL YEAR BUDGET
A RESOLUTION TO ADOPT THE FINAL BUDGET FOR VIRGIN TOWN, FISCAL YEAR
BEGINNING JULY 1, 2026, THROUGH JUNE 30, 2027

WHEREAS, Virgin Town has reviewed its financial needs for the above Fiscal Year, and

WHEREAS, The town must submit the Fiscal Year 2026-2027 Final Budget in compliance with State law setting forth Municipal requirements; and,
