1. Call to Order by Mayor Wampler at 12:00pm

Council member Hickman motioned to approve the minutes and business licenses listed on the consent agenda. Council member Shaw seconded the motion. All council members voted aye (5-0).

4. Ordinance 2026-17: Animal Control Interlocal Agreement. Discuss and possibly deny, continue, or adopt Ordinance 2026-17 approving an Animal Control Interlocal Agreement.

Council member Hoogland-O'Brien indicated the animal control ILA was discussed in the work session and has spoken with Weber County Attorney and Shelter Staff about the questions raised then. The questions the City had about the fee structure were due to the language in the agreement. The intent is for the City to pay fees according to the formula set forth in the agreement and previously provided. The County has agreed to clarify the language. Council member Hoogland-O'Brien suggested that, with that correction to be made, the council proceed to approve the agreement. Council member Hickman asked about the time criticality of the ILA. Mayor Wampler asked about what if there is no agreement on the fee structure. It can be amended.

Council member Hoogland-O'Brien motioned to adopt the Animal Control ILA subject to clarification of the formula and fee structure language in the agreement. Council member Shaw seconded the motion.
