Mayor Bruno announced that she had talked to Rick Wixom, the current Town manager, and Thomas Dansie, the current Director of Community Development, and that Tom's official day as the new Town Manager would be March 25, 2026. She expressed that Rick and Tom would be working closely, so if someone needed a quick answer on something, to involve Wixom, but if it was a long-term thing, to involve Dansie.

B. Administrative Action Items

- 1. Request to Sell and Serve Alcohol on the Town Field, as Required by Town Code Section 7-6-13(E), Located at 126 Lion Blvd, for the St. Patrick's Day Event. Applicant: Cade Campbell, Zion Canyon Visitors Bureau. Staff Contact: Robin Romero**

Romero stated that Kade Campbell, on behalf of the Zion Canyon Visitors Bureau, requested to hold his St. Patrick's Day event on the Springdale Town Field and wanted to be able to serve alcohol. The alcohol would be provided by Zion Brew Pub. Mayor Bruno clarified that the applicant had met all of their requirements, and Romero confirmed.

Pat Campbell made a motion to approve the request by Cade Campbell Zion Canyon Visitors Bureau to sell and serve alcohol in Springdale Town Field located at 126 Lion Boulevard at Springdale on March 21, 2026, finding that the Applicant has complied with section 7-6-13) of the Springdale Town Code and authorizes the Mayor to sign. Pat Campbell made a motion that Town Council as a local business licensing authority has reviewed this Local Authority Consent for a Single Event Permit request for February 20th, 2026, and gives written consent to the Alcohol Beverage Services Commission to consider the issuance of a temporary single event permit to Zion Canyon Brew Pub LLC located at 126 Lion Boulevard, Springdale, UT to store, sell, offer for sale, furnish, or allow the consumption of an alcohol product on the event premises of the applicant, under the following authorities: Utah State Code Section 32B-9-201 and authorizes the Mayor to sign.
