2. SCHOOL FEES PUBLIC HEARING - 6:00 PM

Background and Context: To preserve equal opportunity for all students and to limit diversion of money and school and staff resources from the basic school program, each Local Education Agencies fee policies shall be designed to limit student expenditures for school-sponsored activities, including expenditures for activities, uniforms, clubs, clinics, travel, and subject area and vocational leadership organizations, whether local, state, or national. (Reference: R277-407-6(11)). "Fee" means something of monetary value requested or required by a Local Education Agency as a condition to a student's participation in an activity, class, or program provided, sponsored, or supported by a school. (Reference: R277-407-2(3)(a)) In accordance with state statute, USBE Rule, and District Policy, the Board of Education provides two opportunities for the public to be presented a school's fee schedule and to give input prior to the adoption of the fees. President Weller acknowledged that all required training was completed by the required parties.

6. ACTION ITEMS:

A. 2026-2027 Trustland Plans

1. The idea of trust lands began with Thomas Jefferson who believed that a strong democracy is founded upon education for all and proposed that land be reserved in each new state for public schools. At statehood in 1896, the federal government transferred land to the new state of Utah to provide financial support for public education and 11 other state institutions. Along with these trust lands, Congress also created endowments, permanent funds, for each beneficiary with annual interest

income supporting each beneficiary institution. Trust land parcels were largely allocated by apportioning the state into townships, each six-by-six miles, and dividing each township into 36 square-mile sections. Utah was given sections 2, 16, 32, and 36 in each township for public schools, resulting in a checkerboard of land ownership. All other designated state institutions were granted fixed amounts of acreage. Today, on behalf of the 12 beneficiaries designated by Congress, SITLA manages Utah's 3.4 million acres of trust land generating revenue through energy and mineral leases, rent, and royalties; real estate development and sales; and surface estate sales, leases, and easements. Since 1994, SITLA has generated \$1.9 billion in revenue to help grow the Permanent School Fund from \$50 million to \$2.5 billion. School LAND Trust Funds are interest income from Utah's \$2.5 billion Permanent School Fund endowment, which are distributed annually to Schools within South Summit School District to support the education of the students enrolled in that school during that academic year. School's have a community council that determines the best way to achieve the goals for their school using those funds. The Board of Education approves all plans and amendments.

B. 2026-2027 TSSA PLANS

1. The Teacher and Student Success Act (TSSA) provides a framework and funding for schools to improve school performance and student achievement. Each school is required to create a plan that includes a list of proposed expenditures, an explanation as to how the expenditures relate to the school's plan, outline how the school will measure its success through participation in the program, articulate the school's current level of performance on the measure of its success a list of the prior school year's expenditures, the list of actual expenditures, the school's level of success on the prior year's measures, and how the expenditures influenced the school's level of success. In developing a school's TSSA plan, the principal receives input from the school community council, school-level educators, and parents of the school. School Community Councils shall select a component of the approved Teacher and Student Success Plan for the school's council to address within the council's school LAND trust Program. After approval, each school posts their TSSA plan on their school website.
