A RESOLUTION ADOPTING THE FISCAL YEAR 2026-2027 BUDGET

- 1. Adoption of Fiscal Year 2027 Budget.** The budget for fiscal year 2026-2027, as set forth in the attached exhibit, is hereby approved and adopted.
- 2. Effective Date.** This Resolution is effective immediately upon passage.
