1. **Report of the Executive Director.** Executive Director Wood gave an update on the recent closing of the Downtown bonds for the Housing & Transit Reinvestment Zone. The agency had a successful response from investors and closed on a 6.25% interest rate. Due to factors like the Agency's good creditworthiness and solid financial planning and representation by its underwriter, DA Davidson, the Agency received ten times the amount of orders from investors than bonds which lead to drop in the final interest rate and an increase in project funds of nearly a million dollars.

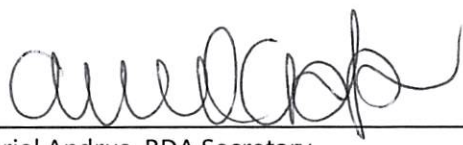
