RESOLUTION NO. 26-15

**A RESOLUTION OF THE CITY OF TAYLORSVILLE APPROVING
YEAR-END FINAL AMENDMENTS TO THE
2025-2026 FISCAL YEAR BUDGET**

WHEREAS, the Taylorsville City Council (the “Council”) met in regular session on June 3, 2026, to consider, among other things, approving year-end final amendments to the 2025-2026 fiscal year budget; and

WHEREAS, the City administration and Budget Officer have presented proposed amendments to the 2025-2026 fiscal year budget as set forth in Exhibit “A” attached hereto and incorporated herein by this reference; and

WHEREAS, the Council finds that the proposed amendments are necessary and appropriate for the efficient administration of City operations and public purposes; and

WHEREAS, the Council further finds that all legal prerequisites to the adoption of the proposed amendments to the 2025-2026 fiscal year budget have been satisfied in accordance with applicable provisions of Utah law.

NOW, THEREFORE, BE IT RESOLVED by the Taylorsville City Council as follows:

Section 1. Adoption of Budget Amendments. The amendments to the 2025-2026 fiscal year budget, attached hereto as Exhibit “A” and incorporated herein by this reference, are hereby approved and adopted as the final amendments to the Budget of the City of Taylorsville for the fiscal year beginning July 1, 2025, and ending June 30, 2026.

Section 2. Administrative Action. The Mayor, Budget Officer, City Recorder, and other appropriate City officials are hereby authorized and directed to undertake all actions reasonably necessary to implement and administer the approved budget amendments consistent with this Resolution and applicable law.

This Resolution, assigned Resolution No. 26-15, shall take effect immediately upon passage, approval, and posting as required by law.
