**A RESOLUTION ADOPTING THE TOQUERVILLE CITY INTERIM BUDGET
FOR FISCAL YEAR 2026-2027**

RECITALS

WHEREAS pursuant to Utah Code 59-2-924 (1)(s) and 59-2-924 (8)(a)(i), the City's Budget Officer prepared and submitted an Interim Budget for Fiscal Year 2026-2027 to the City Council on June 3, 2026;

WHEREAS in conjunction with the Tentative and Interim Budgets, the Property Tax Impact Schedule has been presented to the City Council as defined in Utah Code 59-2-924 (8)(b);

WHEREAS the Interim Budget includes projected revenue from a proposed tax increase that, subject to 59-2-924 (8)(c), has been set aside, in a restricted budget account, an amount of the taxing entity's general fund revenue that is no less than the amount of additional ad valorem tax revenue that would be generated by the taxing entity's proposed tax rate increase;

WHEREAS the Interim Budget is in effect from July 1st to the date on which the City adopts a final budget;

WHEREAS the City Council reviewed the Interim Budget and scheduled a public hearing to receive public input which was duly noticed and held on June 3, 2026, allowing residents to provide comments on the proposed Interim Budget;

WHEREAS the City Council has determined that the proposed Interim Budget reflects the priorities and needs of the community and complies with all applicable legal requirements;

RESOLUTION

NOW THEREFORE, be it resolved by the City Council of Toquerville City, as follows:

The budget for Toquerville City for the Fiscal Year 2026–2027, as presented as Exhibit A, is hereby adopted as the Interim Budget for the City.
