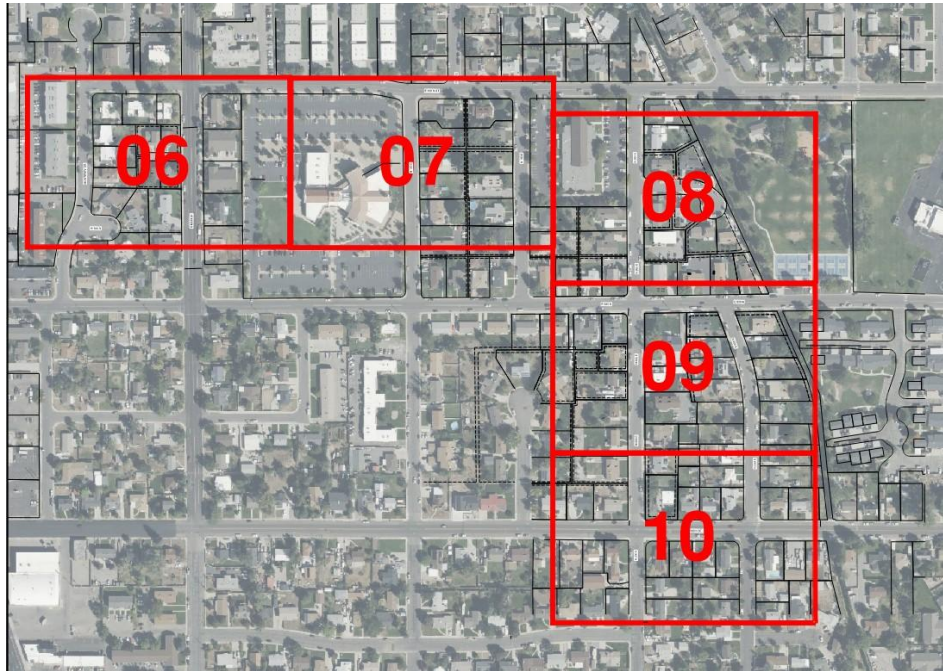
3:00 PM. Rebecca Gourley called the meeting to order.

DRC Action: Chris Clements motioned to approve the administrative site plan for the P.098995 Lumen project. Rick Sabey seconded the motion.

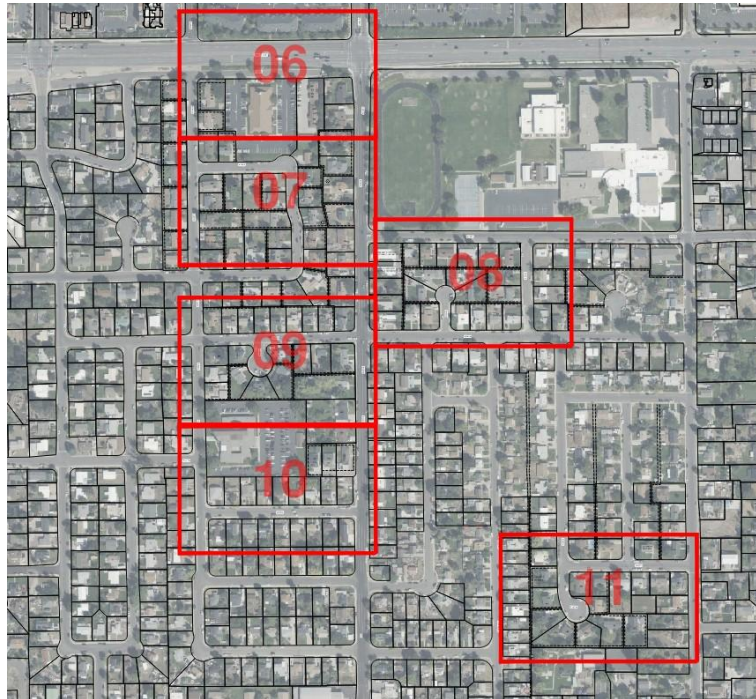

The DRC had no further comments. Rebecca Gourley requested a motion.

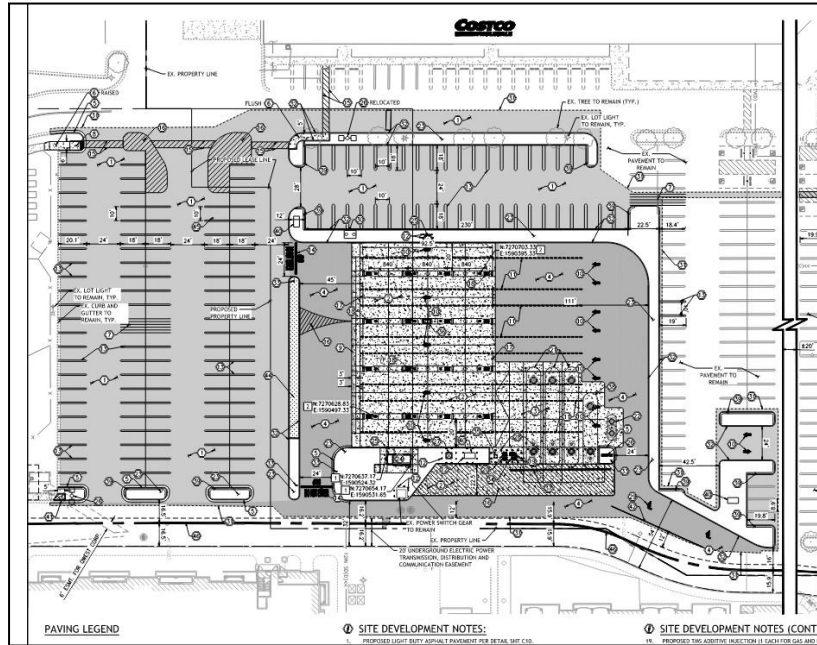
DRC Action: Derek Spencer motioned to forward the plat amendment for Spaugy Plat C to the planning commission. Kody Potter seconded the motion.
