

ORDINANCE NO. 26-11

AN ORDINANCE AMENDING SECTION 12.24.175(B) AND ENACTING SECTION 12.24.185 OF THE MURRAY CITY MUNICIPAL CODE RELATED TO MURRAY ARMORY RENTAL FEES.

BE IT ORDAINED BY THE MURRAY CITY MUNICIPAL COUNCIL:

Section 1. Purpose. The purpose of this ordinance is to amend section 12.24.175(B) and enact section 12.24.185 of the Murray City Municipal Code to establish Murray Armory rental fees.

Section 2. Amendment to section 12.24.175(B) of the Murray City Municipal Code. Section 12.24.175 of the Murray City Municipal Code shall be amended to read as follows:

12.24.175: PARKS AND RECREATION FEES:

...

B. With the exception of the Murray Park Center Membership fees, the Murray Parkway Golf Course Green Fees and Rentals, the Murray Park Outdoor Swimming Pool Fees, and the Murray Armory rental fees, the Mayor shall establish all Parks and Recreation related fees.

Section 3. Enactment of section 12.24.185 of the Murray City Municipal Code. Section 12.24.185 of the Murray City Municipal Code shall be enacted to read as follows:

12.24.185: MURRAY ARMORY RENTAL FEES:

A. Purpose: The purpose of this section is to establish fees for the rental of the Murray Armory.

B. The Murray Armory rental fees shall be as follows:

Available Hours	Resident Fee	Nonresident Fee
Rates Monday through Thursday:		
Morning: 8am – 2pm	\$400	\$800
Evening: 4pm – 10pm	\$450	\$900
All Day: 8am – 10pm	\$750	\$1500

Rates Friday through Sunday:		
Morning: 8am – 2 pm	\$450	\$900
Evening: 4pm – 10pm	\$500	\$1000
All Day: 8am – 10pm	\$800	\$1600

1. The rental fee includes the use of tables, chairs, Audio/Visual (A/V) equipment, firepit, refrigerator, food preparation area, and an attendant to provide general assistance during rental time.
2. The Mayor shall set all other fees associated with the Murray Armory including, without limiting, damage/cleaning deposit, wedding and reception fees, city alcoholic beverage permit (where applicable), and when used, a food truck fee.
3. If alcohol is to be served, applicants shall be responsible for consulting with the Department of Alcoholic Beverage Services and obtaining any required permits (e.g., Single Event Permit, Temporary Beer Event Permit). All permit fees assessed by the Department of Alcoholic Beverage Services shall be the sole responsibility of the applicant.

Section 4. Effective date. This Ordinance shall take effect upon first publication.

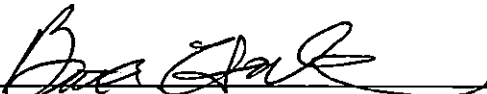

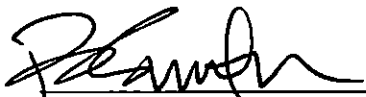
