The Council will receive a briefing on a resolution that would authorize the Mayor to enter into the proposed addendum No.10 to the Interlocal Agreement with UTA to implement 2026-27 Frequent Service Network (FSN) Routes. Frequent service is a goal for buses to arrive at least every 15 minutes. This agreement covers the routes on 200 South, 900 South, 2100 South, and 1000 North. The interlocal agreement signed in 2018 is for twenty years, with a goal of full implementation of the FSN Routes as described in the City's Transit Master Plan.

 - (B) prevent the public body from completing the transaction on the best possible terms.
 - (ii) the public body previously gave public notice that the property would be offered for sale, and
 - (iii) the terms of the sale are publicly disclosed before the public body approves the sale.
- f. discussion regarding deployment of security personnel, devices, or systems.
- g. investigative proceedings regarding allegations of criminal misconduct.

A closed meeting may also be held for attorney-client matters that are privileged pursuant to Utah Code § 78B-1-137, and for other lawful purposes that satisfy the pertinent requirements of the Utah Open and Public Meetings Act.
