PLANNING COMMISSION UPDATE

Lisa Graham stated the trail and streets meeting went well. Everyone was respectful and expected this meeting. Residents are in favor of trails that connect Elk Ridge to Salem and the country trail that leads to Forebay as long as it doesn't impact them. A trails map has been created since 2006 it was brought up that the plan was divisive then and it was allowed to be left alone and not acted upon. The majority do not want new trails in existing neighborhoods, and felt the survey was not clear on the actual cost, (not the financial cost), of what they would have to give up for street parking. Rocky Mountain Way has safety concerns and would like an off-street trail. Canyon View would like an off-street trail as well. Someone would like a cemetery, and most people were unaware of the WUI tax

3. GOVERNOR COX EXECUTIVE ORDER 26-02 DROUGHT, ELK RIDGE WATER CONSERVATION DISCUSSION

Governor Cox Order has recommendations, not a mandatory order. City will issue a resolution in support with recommendations from the city such as odds and evens watering on specific days, but not mandatory restrictions. The resolution will be drafted and emailed to council and a poll vote will be taken. The largest water users like the churches could be notified about conserving water.

4. CITY RECORDER APPOINTMENT

Mayor Haddock stated that Royce will be retiring. The city has interviewed several individual and have offered the position to Spencer Foster. He will take over the city recorder position which is a mandatory position the city has to have. Royce will be staying on to train Spencer for several months.
