Legislative Update <i>by Dr. Blodgett</i>	A lot of the bills will be pointed toward public health. • Changes made to raw milk availability • Study tobacco in the interim – enforcement of specialty shops move to Department of Agriculture • Push to remove all funding to LHDs from the state • Changes to e-cigarette tax funding • Attempt to change immunization requirements for attending school
Approval of Amendments to the non-public drinking water rule	A lot of work going on to help with the state-health department relationship. Hearing officer's report of the public hearing • Commissioner Celeste Meyeres served as the hearing officer • Public Hearing was held at the Southwest Utah Public Health Department in St. George. • If this moves forward there will be a way to move the Southwest Utah Public Health Department out and the individual counties in. Report of other public comments • Less than 10 members of the public attended. All were in favor of the proposed amendment to the non-public drinking water rule • 4.1.3 amendment – The building is to be serviced by water hauling as approved, and verified by the county within which the property is located. • Remove 6.0 water hauling completely from the non-public drinking water rule. The health department will send a letter to Clerk, Planning, Cities, Health Board Liaisons and Board members. Mr. Kaden Figgins made the motion to approve the proposed amendments (sections 4 and 6) to the non-public drinking water rule as presented with an effective date of July 8, 2026, Ms. Jerica Bauer seconded. Passed unanimously.
Proposed Changes to the Fee Schedule <i>by Cameron Mitchell</i>	Hearing officer's report of the public hearing • Cameron Mitchell served as the hearing officer • Advertised for the required amount of time and held a public hearing as required. • Public Hearing was held at the Southwest Utah Public Health Department in St. George. There was no public in attendance. Report of other public comments • No members of the public attended. We try to maintain consistency when looking at the fees. The fees are based off hourly amount of how long it is taking to perform the services. • Food Establishments (new fee) – Change of ownership ○ Bridge the gap when establishments are sold to a new owner

- Update to the septic system and alternative septic system fees as this is taking more time
- Existing septic inspection – the health department was getting very few of these and the liquid waste haulers will take over that verification
- Getting requests for complex pool systems so those plan review fees were included to address the more in-depth look this requires
- Updates to clinical services for giving vaccines and the flu shots
- CPR class fee established

Commissioner Jerry Taylor made the motion to approve the proposed changes to the fee schedule as presented. **Mr. Kaden Figgins** seconded. Passed unanimously.
