

RESOLUTION 2026-9

A RESOLUTION AMENDING THE ORANGEVILLE CITY FEE SCHEDULE AND ADOPTING AN UPDATED CONSOLIDATED FEE SCHEDULE

WHEREAS, Orangeville City (“City”) is authorized under Utah Code §§10-3-717 to establish and collect fees for services provided by the City; and

WHEREAS, the City Council periodically reviews and updates the City Fee Schedule to ensure fees reasonably reflect the cost of providing municipal services and remain consistent with current operations; and

WHEREAS, the City Council desires to amend and adopt an updated consolidated Fee Schedule attached hereto as **Exhibit A**; and

WHEREAS, the City Council finds that adoption of this Resolution is in the best interest of the health, safety, and welfare of the residents of Orangeville City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ORANGEVILLE CITY, UTAH:

Section 1. Adoption of Amended Fee Schedule

The Orangeville City Fee Schedule is hereby amended and replaced in its entirety with the Fee Schedule attached as **Exhibit A**, which is incorporated herein by reference.

Section 2. Authority to Collect Fees

City staff are authorized and directed to collect fees in accordance with the adopted Fee Schedule.

Section 3. Administrative Updates

The Mayor and City Recorder are authorized to make non-substantive corrections (formatting, numbering, clerical errors) to the Fee Schedule as necessary.

Section 4. Severability

If any provision of this Resolution or the attached Fee Schedule is held invalid, such invalidity shall not affect the remaining provisions.

Section 5. Effective Date

This Resolution shall become effective immediately upon adoption and shall remain in effect until amended or repealed by the City Council.
