## RESOLUTION No. 2026-14

### A RESOLUTION EXPRESSING GRATITUDE TO CARLTON CHRISTENSEN FOR HIS WORK AND SERVICE TO THE CENTRAL WASATCH COMMISSION

**WHEREAS**, Carlton Christensen, a former member of the board of trustees of Utah Transit Authority (“*UTA*”), has served as an Ex Officio Commissioner of the Central Wasatch Commission (the “*Commission*”) since 13 July 2020, actively participating in the Commission to better assure the wise stewardship of the Wasatch mountain range in Salt Lake, Summit and Wasatch counties—including its watershed, recreational areas and natural beauty—so that future generations can continue to benefit from that wonderful and integral part of Utah’s natural environment; and

**WHEREAS**, Carlton gave generously of his time, energy, talents, knowledge and UTA resources to further the purposes of the Commission, and in so doing richly benefitted the Commission, its members and the present and future inhabitants of Utah’s “Wasatch Front” and “Wasatch Back;” and

**WHEREAS**, Carlton has resigned from his office in the Commission due to recently enacted state law repealing UTA’s 3-member board of trustees and changing the body to a 7-member transit commission; and

**WHEREAS**, on 22 June 2026 the Commission’s governing body (the “*Board*”) met in regular session to consider, among other things, expressing appreciation to Carlton for his work and service to the Commission; and

**WHEREAS**, after careful consideration, the Board finds that it is in the best interests of the Commission, its members and its constituents to so act;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Central Wasatch Commission that the Commission expresses its deep gratitude and appreciation to Carlton Christensen for his diligence, work, vision and leadership as an Ex Officio Commissioner of the Central Wasatch Commission, with due acknowledgment of the support given by Carlton’s family to make such efforts possible.

This Resolution, assigned no. 2026-14, shall take immediate effect as soon as it shall be published or posted as required by law and deposited and recorded in the office of the Commission’s secretary, or such later date as may be required by Utah statute.
