REGULAR SESSION:

1. Reidhead Presentation

Commissioner Meyeres provides a quick overview of Reidhead Forest Management, LLC's presentation and introduces them.

The Board turns the time over to the Reidhead's, Duke and Tony who are attending virtually, to present to the Board. Duke informs the board about some projects the business is working on, including applying for a grant that will allow the company to purchase a kiln.

He also speaks to a bio-mass project they are working on. He asks the Board for a letter of support to help aid in the grant process. Duke also speaks to other issues the LLC is facing while also speaking to potential solutions.

The Board discusses the information presented, offers support, and asks questions that the Reidhead brothers answer. The Board asks staff to pull up the drafted letter of support for Reidhead Forest Management, LLC.

He also asks if the signage would apply for only County roads or UDOT roads as well. Board Member Spencer mentions the history of the issue in Iron County.

Commissioner Meyeres asks Taylor Glover to speak about the County road rights. He also provides an overview of additional potential benefits of the ordinance.

3. County Commissioner Report

Commissioner Meyeres gives the Board an update on Kane County Commission updates including a meeting with DOI and a national parks update.

4. Other Discussion Items

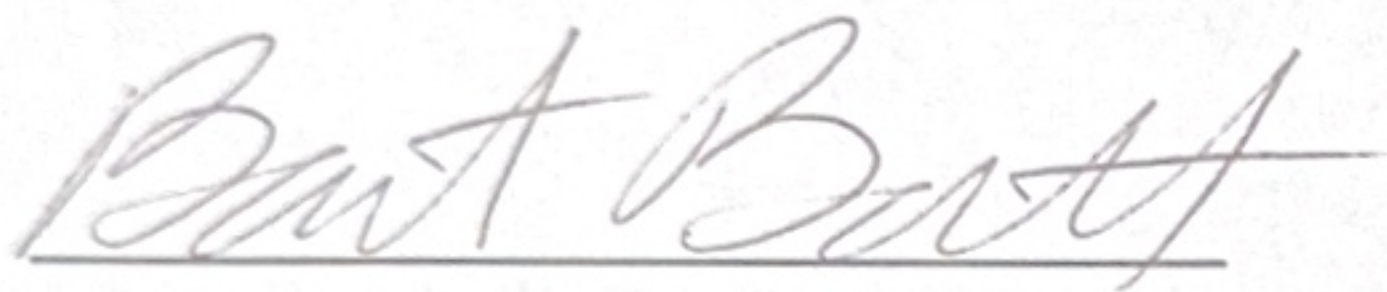

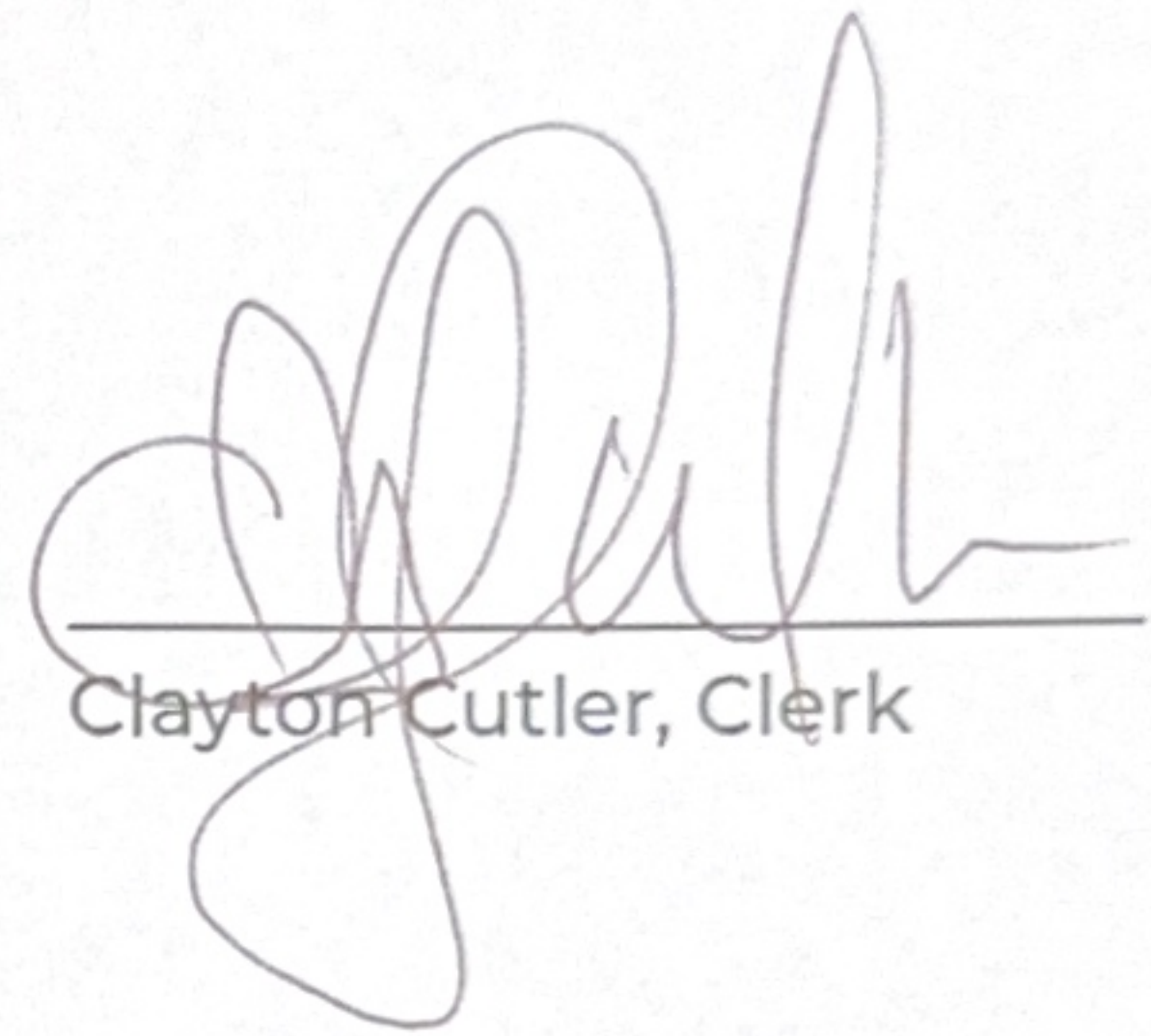
