RESOLUTION 7-2026

A RESOLUTION OF THE HUNTINGTON CITY COUNCIL ESTABLISHING A DONATION AND
SPONSORSHIP POLICY AND SCHEDULE FOR HUNTINGTON CITY

WHEREAS, Huntington City receives requests from individuals and local groups for donations and sponsorships; and

WHEREAS, the City Council finds that donations and sponsorships may serve a valid public purpose when they promote the health, safety, welfare, recreation, culture, education, or general well-being of Huntington City residents; and

WHEREAS, the City Council desires to establish standard donation and sponsorship guidelines to ensure consistency, transparency, and responsible stewardship of public funds; and

WHEREAS, the City Council recognizes that circumstances may arise where a request warrants consideration beyond the standard guidelines established herein;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF HUNTINGTON CITY, UTAH, AS FOLLOWS:

SECTION 1. ELIGIBILITY

Donations and sponsorships authorized under this Resolution shall be limited to:

- A. Individuals who reside within the corporate limits of Huntington City; and
- B. Local groups, organizations, or entities that primarily serve or benefit residents of Huntington City.

SECTION 2. APPROVAL PROCESS

All requests for donations and sponsorships shall be submitted to the Huntington City Council for consideration. Approval of any donation or sponsorship shall require action by the City Council during a duly noticed public meeting and shall be reflected in the official meeting minutes.

SECTION 3. STANDARD DONATION AND SPONSORSHIP SCHEDULE

The following standard donation and sponsorship amounts are hereby established:

- A. Individual Residents: Up to One Hundred Dollars (\$100.00) per request.
- B. Local Groups and Organizations: Up to Two Hundred Dollars (\$200.00) per request.

SECTION 4. CITY COUNCIL DISCRETION

The donation and sponsorship amounts established in Section 3 are intended to serve as standard guidelines. Upon determining that a request serves a valid public purpose and benefits the residents of Huntington City, the City Council may approve a donation or sponsorship in an amount greater than the standard schedule during a duly noticed public meeting.

SECTION 5. BUDGET LIMITATION

All donations and sponsorships approved pursuant to this Resolution shall be subject to the availability of appropriated funds. In no event shall the total amount of donations and sponsorships approved by the City Council exceed the amount budgeted and appropriated for such purposes during the applicable fiscal year.

SECTION 6. REPEAL OF CONFLICTING RESOLUTIONS

Any prior resolutions, policies, or provisions inconsistent with this Resolution are hereby repealed to the extent of such conflict.

SECTION 7. EFFECTIVE DATE

This Resolution shall take effect immediately upon its adoption.
