

**WASHINGTON COUNTY RAP ADVISORY BOARD
MEETING MINUTES
DECEMBER 2, 2025**

Chair Glenn Webb called the RAP Advisory Board to order at 11:05 PM on Tuesday, December 2, 2025, in the 3rd Floor Training Room of the Washington County Administration Building, 111 E. Tabernacle St., St. George, UT. Those in attendance were: RAP Advisory Board: Glenn Webb, Michael Lee, Ginger Nielson, Trevor Sanders, Sheryl Snow, Dimon McFerson, and Tony Allen. Others in attendance were Deputy County Attorney Steven Scott and Deputy Clerk Jayanne Lewis.

WELCOME

Chair Glenn Webb welcomed all in attendance and it was determined that a quorum existed for voting on action items.

APPROVAL OF MINUTES FROM NOVEMBER 18, 2025

MOTION: Motion by Tony Allen to approve minutes from November 18, 2025. Motion seconded by and carried by a unanimous vote

FUNDING RECOMMENDATION REVIEW:

Chairman Glen Webb thanked the board members for submitting their funding recommendations. Mr. Webb also reminded the board the RAP budget for funding in 2026 is \$755,000.00. Board members suggested they present the average recommended funding for each organization and determine final funding recommendations based of the final total number. The board discussed and agreed to present a recommendation list, totally \$755,000.00. All eligible applications were reviewed with funding recommendations made. The board agreed to present the funding recommendations to the Washington County Commissioners for final approval.

OTHER BUSINESS:

It was determined a 2027 Chair should be appointed during this meeting. Michael Lee nominated Glenn Webb to serve as Chairman for another term.

MOTION: Motion by Michael Lee to appoint Glenn Webb as Chairman for 2027. Motion seconded by Ginger Nielson and carried by a unanimous vote with Tony Allen Abstaining.

Michael Lee was nominated by Ginger Nielson to serve as Vice Chairman for another term.

MOTION: Motion by Ginger Nielson to appoint Michael Lee as Vice Chairman for 2027. Motion seconded by Glenn Webb and carried by a unanimous vote.

Dimon McFerson recommended a motion be made to limit the number of times a board member can serve as Chairman. Steven Scott said it would have to be addressed by amending the board by-

laws during a future meeting. It will be added to a future agenda.

It was determined to have the first meeting of 2026 in June 2026. The 2026 future meeting schedule will be decided then.
