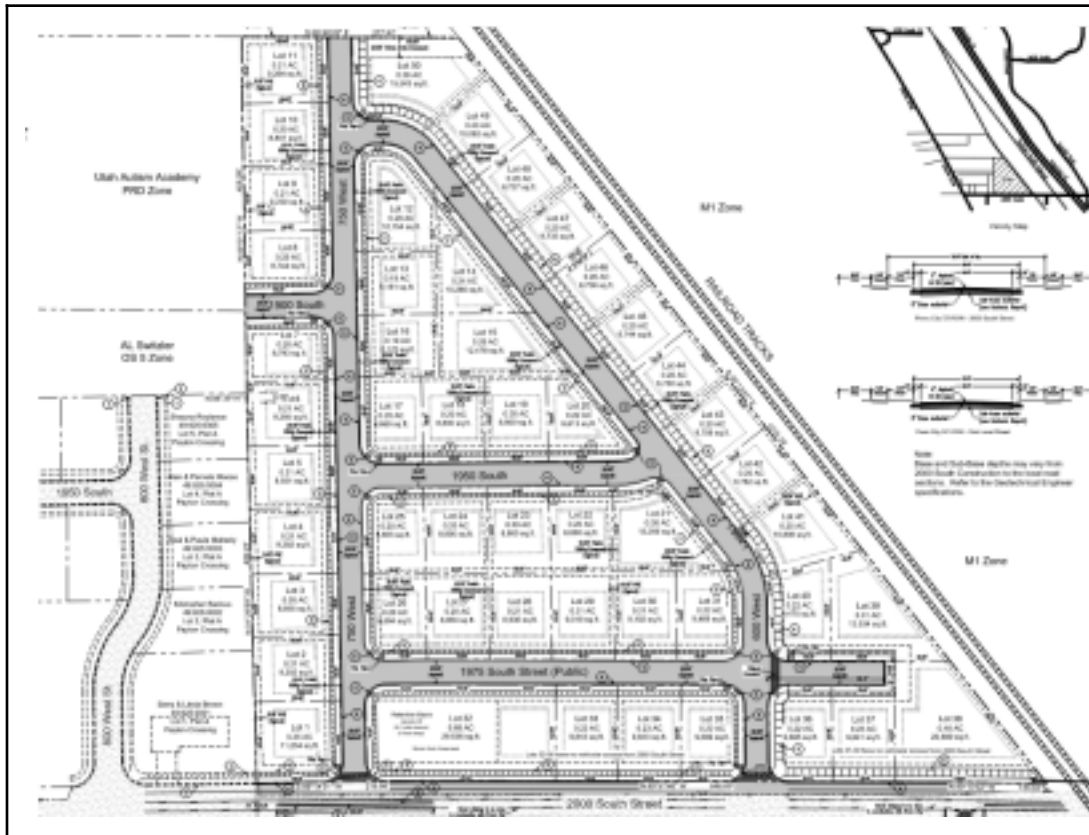
11:01 a.m. Jared Hall called the meeting to order.

- 1. Preliminary Plat** - Whitestone Subdivision - Located generally at 710 West 2000 South

Rebecca Gourley introduced the Preliminary Plat for the Whitestone Subdivision. The applicants, Nathan Horan and Julie Smith, requested to subdivide the property located generally at 710 West 2000 South into 50 lots. Lot sizes for the plat range from 8,000 sqft to 20,000 sqft, with most lots averaging around 9,000 to 10,000 sqft.

The applicant, McKenna Christensen on behalf of Cole

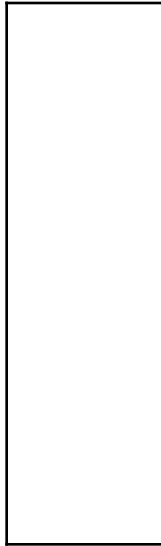
West, requested to rezone the property located at 355 West
