1. CALL CITY COUNCIL MEETING TO ORDER

- #### **2. FUNDING DISCUSSION-** The Ferguson Group (TFG)
- Kristy More, Gabrielle Bronstein and Mike Miller, with The Ferguson Group, joined the meeting via Microsoft Teams to present an overview of how the organization supports clients and communities through grant funding, particularly for water and wastewater projects. TFG provides weekly grant updates, custom funding guides, and strategic funding plans to match projects available programs. They explained that the firm has been in business for 44 years, works exclusively with local governments and public agencies, and has secured billions of dollars in grant funding. They emphasized the firm's strong grant success rate, especially for water projects with the Bureau of Reclamation, U.S. Army Corps of Engineers, and EPA, attributing this to early strategic positioning, preparing projects in advance of funding announcements, and integrating advocacy with grants to closely tracking federal budget. The firm will email further information to Ballard City Secretary so that the Board Members and City Council can contact TFG directly with questions and review the PowerPoint presentation and related materials.

Council Member Steve Secrest reported that TFG pursues to find grants that match Ballard City's needs and works with Congress and funding agencies to secure those funds. He noted that potential funding for water projects might become available as early as 2028. He also mentioned that TFG'S advocates have researched Ballard City
