Claire advised the Planning Commission the process for ordinance updates and should email comments. In the future, ordinances will be more legal or administrative, the City Attorney recommended if the Planning Commission has recommendations not to send to council, but document in a table and present the comments with the ordinance to the City Council as soon as possible.

There isn't consideration for conditional uses and development agreements. Need to vote at the next meeting regarding the two ordinances. State law says we cannot require a development agreement for every subdivision. Topography is important and the legislature was poised to pass a state law for every city allowing oil and gas pipelines as permitted use. What is the city going to do to make sure these are passed

in a timely manner? These ordinances are administrative and legal versus policy.

The Planning Commission's homework is to review the enacted one page 19.03 Development Agreements and four page 19.84 Conditional Uses, to replace the current 19.84 Conditional Uses. If there are concerns and comments forward to Claire. The ordinance should stay plain, until you receive applications for individual impacts on the record.
