MINUTES
WFRC || Transportation Coordinating Committee
June 18, 2026

WFRC Transportation Coordinating Committee Meeting was held at WFRC Office, 41 N Rio Grande Street, Salt Lake City and via Zoom.

1. Welcome & Consent Agenda [00:00:03]

Mayor Mark Shepherd, Trans Com Chair, called the meeting to order at 1:34pm. After welcoming committee members and guests, introductions were made around the table for those attending in person, and the names of those attending online were read.

a. ACTION: Minutes of the Trans Com Meeting held April 30, 2026 [00:02:33]

A motion was made by Salt Lake City Councilmember Dan Dugan and seconded by Carlton Christensen, UTA Trustee, that the minutes of the meeting be approved as presented. The affirmative motion was carried unanimously.

2. Chair Report [00:02:53]

Mayor Shepherd mentioned that the 21st Century Road to Housing Act will likely pass the House, as it has already been approved by the Senate. This Act has a positive effect on programs like Community Development Block Grant (CDBG), allowing for more impactful development.

3. Public Comment [00:04:40]

Mayor Shepherd opened the time for public comment. There were no comments made by members of the public.

4. Transportation Improvement Program (TIP) [00:04:55]

a. Report: Board modifications to the 2026-2031

Mayor Shepherd turned the time to Ben Wuthrich, WFRC, who reported that since the last meeting of Trans Com, WFRC received requests to modify the current 2026-2031 Transportation Improvement Program (TIP). These modifications were approved by the Regional Council at their May meeting but did not require a new air quality conformity analysis or a 30-day public comment period. Mr. Wuthrich referred Committee members to the meeting materials for information regarding these modifications and offered to answer any questions..

b. ACTION: Board modifications to the 2026-2031 TIP [00:09:42]

Mr. Wuthrich continued his report, stating that there were new requests to modify the 2026-2031 Transportation Improvement Program (TIP). These modifications require action from Trans Com and the State Transportation Commission but do not require a new air quality conformity analysis or a 30-day public comment period. Mr. Wuthrich briefly discussed each project. **ACTION: [00:21:43]** Commissioner Jlm Harvey made a motion to approve the resolution to modify the 2026-2031 TIP as requested, seconded by Mayor Sheri Bingham. The affirmative vote was unanimous.

c. ACTION: Release of Draft 2027-2032 TIP and Air Quality Conformity Analysis for public comment [00:22:00]

Mr. Wuthrich then stated that WFRC staff has been working with the Utah Department of Transportation (UDOT), the Utah Transit Authority (UTA), and the cities and counties in the region to compile the list of proposed projects for inclusion in a draft 2027-2032 TIP. The attachments included in the meeting materials represent the proposed projects for the Salt Lake and Ogden / Layton Urban Areas. Mr. Wuthrich discussed examples of the projects and reminded the group that the TIP public comment interactive map will be a key part of the process for receiving public comments from June 27 through August 2, 2026. **ACTION: [00:35:04]** Mayor Dirk Burton made a motion to release the draft 2027-2032 TIP and air quality conformity analysis for public review and comment. Councilmember Dan Dugan seconded the motion, and the affirmative vote was unanimous.

5. Annual Safety Audit [00:35:28]

Mayor Shepherd introduced Fariba Soltani, WFRC Transportation Analyst, who presented information about safety trends and improvement projects that have occurred in the region.

6. Connected Vehicles, Making a Difference [00:52:35]

Mayor Shepherd turned the time to Blaine Leonard, UDOT Transportation Technology Engineer, who has been nationally recognized for his work in Connected Vehicle Technology (CVT). Mr. Leonard presented information on the current applications of CVT in Utah.

7. Other Business and Adjournment [01:25:37]

Mayor Shepherd asked if there were any other business items to bring forward. There were none. He then reminded the group that the next meeting will be held on Thursday August 20, 2026 and entertained a motion to adjourn. Commissioner Jim Harvey made the motion, which was seconded by Councilmember Dan Dugan. The meeting ended at 2:59pm.
