RESOLUTION 2026.XX

A RESOLUTION DISSOLVING THE CHIEF TOQUER RESERVOIR RECREATION COMMITTEE

PREAMBLE

WHEREAS, on September 17, 2025, the Toquerville City Council adopted Resolution 2025.15 establishing the Chief Toquer Reservoir Recreation Committee as a recommending body to assist the City Council with planning and development of the recreational component of the Chief Toquer Reservoir; and

WHEREAS, the Committee was established to provide recommendations regarding recreation planning, funding opportunities, community engagement, and negotiations associated with the anticipated development and management of the recreation area by Toquerville City; and

WHEREAS, the Utah Division of State Parks has expressed its intent to develop, operate, and manage the Chief Toquer Reservoir recreation area as part of the Utah State Park system; and

WHEREAS, the City Council has determined that long-term recreation planning, development, and management are more appropriately undertaken by the Utah Division of State Parks and has adopted Resolution No. 2026.XX expressing its support for that transition; and

WHEREAS, the City Council finds that the purpose for which the Chief Toquer Reservoir Recreation Committee was established has been fulfilled or is no longer necessary, and that dissolving the Committee is in the best interest of the City.

RESOLUTION

NOW, THEREFORE, BE IT HEREBY RESOLVED as follows:

1. The Chief Toquer Reservoir Recreation Committee, established by Resolution No. 2025.15, is hereby dissolved effective immediately upon adoption of this Resolution.
2. The City Council expresses its appreciation to the members of the Chief Toquer Reservoir Recreation Committee for their time, expertise, and service in advancing the City's vision for recreation opportunities associated with the Chief Toquer Reservoir.
3. Resolution Number 2025.15 is hereby repealed in its entirety.
4. This Resolution shall take effect immediately upon its adoption.
