Posting and advertising of this meeting were done in compliance with Utah's Open and Public Meetings Act and State budget requirements.

1. Roll Call:

At 6:04 p.m., Trustee Barth made a motion to open the Salt Lake City Mosquito Abatement District Public Hearing on the 2026 Amended Budget, 2026 Certified Tax Rate, and 2027 Proposed Budget. Her motion was seconded by Trustee Escamilla, and it passed with all in favor. It was confirmed that the meeting was being recorded; roll call was taken, and no conflicts of interest were declared.

2. 2026 General Fund and Capital Projects Fund Budget Amendments:

The Board Members had been given a copy of the 2026 Budget Amendments for the General Fund and the Capital Projects Fund earlier in the week, and CFO Fairbanks had reviewed the amended accounts with the Trustees and explained the reasoning behind each one during June's Regular Board Meeting. Because no public was present and all questions had been answered previously, no further discussion took place.

3. 2026 Certified Tax Rate Hearing:

We are required by law to approve our certified tax rate by 22 June of each year. The State has set our new certified tax rate at .000164, providing a tax revenue of \$8,940,759. Executive Director had provided pertinent data about the certified tax rate during June's Regular Board Meeting. Because no public was present, no further discussion was required.

4. 2027 General Fund and Capital Project Fund Budgets:

CFO Fairbanks had also presented the proposed 2027 General Fund and Capital Projects Fund Budgets with the Board Members during the Regular Board Meeting. There was no further discussion because no public was present.

5. Adjournment:

At 6:07 p.m., Trustee Mooers made a motion to adjourn the Public Hearing for the 2026 Budget Amendments, 2026 Certified Tax Rate, and 2027 Proposed Budgets. This motion was seconded by Trustee Escamilla, and it carried with a unanimous vote.
