1. The constitutional and legal appropriateness of the Board or UPPAC making a determination that an educator violated Utah Code 76-8-502, or another criminal statute, using the “preponderance of the evidence” standard rather than the criminal law standard of “beyond a reasonable doubt.”

When considering the suspension or revocation of an educator license, may the Board or UPPAC expand the plain language of an administrative rule beyond its text?

- a. Specifically, R277-215-2(5)(a) applies to false information contained in an “education-related document.” May the Board or UPPAC interpret or apply this provision to alleged oral statements when no “education-related document” is at issue?
- b. Specifically, R277-217-3(9) requires an educator to report misconduct “by another educator” under certain circumstances. May the Board or UPPAC interpret or apply this provision to an educator’s alleged failure to report his or her own conduct in a manner that could implicate protections against self-incrimination under the Fifth Amendment to the United States Constitution?
