1. Call to Order

6. Project Updates

- The new Hot Springs pump house has been built and is awaiting electrical service. The tank has been filled, and bacteriological testing is complete. An electrical disconnect will be installed on the exterior of the lower existing pump house as a safety precaution.
- The North Ogden Wells protest meeting will be held on **July 14, 2026**.
- The bore for Harrisville Road is scheduled for **September 22, 2026**.
- The 1700 North project is complete.
- Chris Crockett spoke with the attorney for Optic Loop regarding the contract timeline. He also requested that Optic Loop pay its outstanding bill to Bona Vista for the land it is leasing.
- The Jackson property representatives canceled their meeting with management. They will wait until they are further along in the development process before meeting with the Board to discuss the costs associated with required water shares, district-required water storage, and annexation fees.

7. Water Report

Weber Basin at 20.4% and Ogden City and 29%. Farr West wells turned off last week and will be able to recharge a bit. All three wells with Weber Basin are on.

8. Staff and Board Comments

- Mayor Shuman asked about the drilling work taking place across the neighborhood. He noted that construction crews had parked a truck on a customer's lawn over night. Matt stated that the District will address these situations if the city will notify when they occur.
 - Matt provided an update on the railroad crossing project. On the east side of the tracks, the tie-ins have been completed. On the west side, there are still a few dips in the roadway because the second phase of the project is not yet complete. He explained that additional boring work must be completed, which requires a railroad shutdown, before the remaining road repairs can be finished.
 - Chris Crockett reported that Bona Vista contacted Magna 5 to negotiate an agreement regarding the contract. Magna 5 requested payment for the full contract term. Due to ongoing service issues, negotiations are continuing.
 - No further comments were made.
