

**TRANSIT TRANSPORTATION INVESTMENT PROGRAM FUNDS
(TTIF)
COOPERATIVE AGREEMENT # 258067, Amendment No. 1**

This Amendment No. 1 ("Amendment") is entered into effective as of July __, 2026, by and between the Utah Department of Transportation ("UDOT") and High Valley Transit ("Agency") and all other terms and conditions remain in full force and effect.

RECITALS

WHEREAS, UDOT and the Agency entered a TTIF Cooperative Agreement # 258067 ("Agreement # 258067") on July 23, 2024; and

WHEREAS, the Agreement # 258067 provided \$30,300,000 in ST_TTIF Program Funds; and

WHEREAS, in March 2026, the Utah Transportation Commission awarded an additional \$15,000,000 in TTIF funding; and

WHEREAS, the Parties desire to amend the Agreement # 258067 to incorporate said additional funding and the Local Match Amount and Payment Schedule.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing Recitals (which are incorporated into this Agreement by this reference), the mutual covenants and agreements hereafter set forth, the mutual benefits to the Parties to be derived, and for other valuable consideration, the receipt and sufficiency of which the Parties acknowledge, it is hereby agreed as follows:

1. Amendment to Section 2. Local Match Amount and Payment Schedule

Section 2 of the Agreement #258067 is modified as follows:

- The additional \$15,000,000 in TTIF awarded in March 2026 will be delivered to the Agency in six (6) equal quarterly payments (\$2,500,000) beginning July 2026 following execution of this document and the funding table is replaced as follows:
