

RESOLUTION NO. R-26-17

A RESOLUTION OF THE CITY COUNCIL OF GARLAND CITY, UTAH, ESTABLISHING COMPENSATION FOR THE POSITION OF EMERGENCY OPERATIONS CENTER DIRECTOR AND AUTHORIZING AN ANNUAL SALARY BEGINNING WITH FISCAL YEAR 2027

WHEREAS, Garland City recognizes the importance of emergency preparedness, disaster response, continuity of government, and coordination with local, county, state, and federal agencies; and

WHEREAS, the City Council finds that the position of Emergency Operations Center Director serves a critical role in planning, coordinating, and managing the City's emergency management and emergency operations functions; and

WHEREAS, the City Council desires to establish compensation for such position beginning with Fiscal Year 2027; and

WHEREAS, the City Council finds that establishing a modest annual salary for the position is in the best interest of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GARLAND CITY, UTAH, AS FOLLOWS:

Section 1. Compensation Established.

Beginning with Fiscal Year 2027 and continuing thereafter unless modified by subsequent action of the City Council, the position of Emergency Operations Center Director shall receive an annual salary in the amount of Two Thousand Dollars (\$2,000.00).

Section 2. Budget Authorization.

The City Council authorizes and directs that sufficient funds be appropriated in the City's annual budget beginning with Fiscal Year 2027 to provide for the compensation established by this Resolution.

Section 3. Administration.

The Mayor, City Recorder, and City Treasurer are authorized and directed to take such actions as are necessary to implement this Resolution and provide payment in accordance with the City's payroll and financial procedures.



Section 4. Effective Date.

This Resolution shall take effect immediately upon adoption and shall apply to compensation for Fiscal Year 2027 and subsequent fiscal years unless amended or repealed by the City Council.

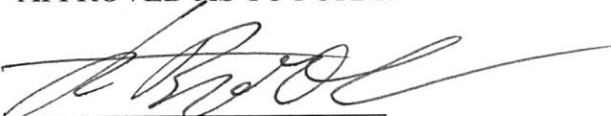
