RESOLUTION NO. 26-25**

**A RESOLUTION OF THE LOGAN CITY MUNICIPAL COUNCIL REPEALING  
RESOLUTION NO. 25-46 WHICH APPROVED LOGAN CITY'S  
WITHDRAWAL FROM THE LOGAN-CACHE AIRPORT AUTHORITY**

**BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF  
LOGAN, UTAH THAT:**

**WHEREAS**, on December 16, 2025, the Logan City Municipal Council adopted Resolution No. 25-46, which approved Logan City's withdrawal from the Logan-Cache Airport Authority (the "Airport Authority");

**WHEREAS**, the Logan-Cache Airport ("Airport") is located within the corporate boundaries of Logan City, and the City has a continuing and substantial interest in matters affecting the operation, maintenance, and development of the Airport;

**WHEREAS**, subsequent to the adoption of Resolution No. 25-46, the City has determined that federal funding from the Federal Aviation Administration ("FAA") for Airport improvements and operations could be at risk if the City proceeds with its withdrawal from the Airport Authority;

**WHEREAS**, the loss of FAA funding would adversely impact the safety, operation, and development of the Airport, which serves an important public purpose for the residents of Logan City and the surrounding region;

**WHEREAS**, the City's participation in the Airport Authority facilitates coordination with other governmental entities and helps ensure the continued receipt of federal and state funding for Airport-related purposes;

**WHEREAS**, the City and Cache County intend to amend the 1992 Interlocal Agreement relating to the Airport Authority to provide that the City will have representation on the Airport Authority's Sponsor Board and will not incur any future financial obligations or liability as a member of the Airport Authority;

**WHEREAS**, upon further consideration of the potential consequences of withdrawal, the Municipal Council has determined that it is in the best interests of Logan City and its residents to repeal Resolution No. 25-46 in its entirety and to maintain the City's membership in the Logan-Cache Airport Authority; and

**WHEREAS**, the Municipal Council finds that repealing Resolution No. 25-46 will preserve the City's ability to participate in decisions affecting the Airport, protect federal funding sources, and promote the continued safe and efficient operation of the Airport.

**NOW THEREFORE, BE IT RESOLVED** by the Logan Municipal Council as follows:

## **SECTION 1. Repeal of Resolution No. 25-46**

Resolution No. 25-46, adopted by the Logan City Municipal Council on December 16, 2025, which approved the City's withdrawal from the Airport Authority, is hereby repealed in its entirety and shall be of no further force or effect.

## **SECTION 2. Continuation of Membership**

Logan City shall continue as a member of the Airport Authority and all rights of the City as a member of the Authority shall remain in full force and effect as if Resolution No. 25-46 had never been adopted.

## **SECTION 3. Authority to Take Necessary Actions**

The Mayor and other appropriate City officials are hereby authorized and directed to take all actions necessary to effectuate the purposes of this Resolution, including but not limited to providing notice of this repeal to the Logan-Cache Airport Authority and to any other governmental entities or agencies as may be required by law.

## **SECTION 4. Severability**

If any provision of this Resolution, or the application thereof to any person or circumstance, is held invalid, such invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are declared to be severable.

## **SECTION 5. Effective Date**

This resolution is hereby adopted and shall be in effect as of the date of its passage.
