

PUBLIC NOTICE Grand County School District Legal Notice - Proposed Tax Rate Hearing In accordance with Section 53G-7-303 and 59- 2-912 Utah Code Annotated, the Grand County School District will hold a public hearing on Wednesday August 19, 2026, at 6:00 p.m. at the Grand County School District Office, located at 264 South 400 East, Moab, Utah. The tax hearing will include the proposed setting of the 2026-2027 tax rate. A copy of the proposed budget and tax rate is on file in the office of the Business Administrator. NOTICE OF PROPOSED TAX INCREASE GRAND COUNTY SCHOOL DISTRICT

The GRAND COUNTY SCHOOL DISTRICT is proposing to increase its property tax revenue.

The GRAND COUNTY SCHOOL DISTRICT tax on a \$511,000 residence would increase from \$1,022.74 to \$1,053.94, which is \$31.20 per year.

The GRAND COUNTY SCHOOL DISTRICT tax on a \$511,000 business would increase from \$1,859.53 to \$1,916.25, which is \$56.72 per year.

If the proposed budget is approved, GRAND COUNTY SCHOOL DISTRICT would receive an additional \$431,503 in property tax revenue per year as a result of the tax increase. If the proposed budget is approved, GRAND COUNTY SCHOOL DISTRICT would increase its property tax budgeted revenue by 3.42% above last year's property tax budgeted revenue excluding eligible new growth.

The GRAND COUNTY SCHOOL DISTRICT invites all concerned citizens to a public hearing for the purpose of hearing comments regarding the proposed tax increase and to explain the reasons for the proposed tax increase. You have the option to attend or participate in the public hearing in person or virtually.

NOTICE OF PROPOSED TAX INCREASE GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY is proposing to increase its property tax revenue.

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY tax on a \$477,000 residence would increase from \$954.69 to \$983.81, which is \$29.12 per year.

The GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY tax on a \$477,000 business would increase from \$1,735.80 to \$1,788.75, which is \$52.95 per year.

If the proposed budget is approved, GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY would receive an additional \$18,046 in property tax revenue per year as a result of the tax increase. If the proposed budget is approved, GRAND COUNTY SCHOOL DISTRICT IN SAN JUAN COUNTY would increase its property tax budgeted revenue by -10.52% above last year's property tax budgeted revenue excluding eligible new growth.
