3.b) Discussion and possible approval of a willing landowner outreach letter to solicit additional Notices of Interest (NOIs).

Board and staff commented on proposed letter. Suggestions include: Add open space numbers from minutes from previous meeting. Narrow the letter down to one page. Bridget Hayes: Highlight this is a voluntary process and OSAC's outreach does not mean that the property is guaranteed to be recommended to County Council. Joan Card: The letter suggests that property has been through criteria, recommended a change to be more general - "may" meet criteria. Mention that they can remain on the land if desired. Jess Kirby: OSAC should pull back on development/sprawl language - suggests striking a balance between development and protection, having open space integrated into development. Jack Kellner: Echoed Jess's comments and desire to shorten to one page. Rachael: Consider word choice on preservation vs conservation/protection.

Next Steps - Dan and Jack to edit. Once edited we can approve via email as long as there is not

discussion. Staff will make edits and send to Lynda for approval.

RE: Opportunity for Voluntary Land Conservation under Summit County Open Space Program

Dear Landowner,

In November 2021, voters in Summit County approved a \$50 million General Obligation Bond (known as the "Open Space Bond") dedicated to conserving open space, supporting agricultural heritage, protecting natural resources, expanding passive recreation, and integrating open space with responsible growth. To date, Summit County has utilized and leveraged these bond funds to protect more than 16,700 acres of land.

The Summit County Open Space Advisory Committee (OSAC) continues to seek willing landowners interested in land conservation projects that may be eligible for funding through this bond program. Based on our review of regional conservation values and working lands across the county, your property may be a candidate for this program. Properties are evaluated by OSAC based on criteria that consider factors such as water protection, development pressure, agriculture preservation, wildlife habitat, heritage, recreation, and community benefit.

Summit County offers several voluntary land protection mechanisms, including fee title purchase, conservation easements, and full or partial donations. Participation in the program is entirely voluntary, and landowners choose the approach that best aligns with their goals and estate plans. Landowners interested in conservation easements can retain ownership of their property, continue agricultural operations, and guide the structure of the agreement.

If you are interested in having your property evaluated, the first step is to submit a Notice of Interest (NOI). The NOI is a no-cost, informational form that informs Summit County of your willingness to have your property evaluated for conservation. There is no obligation to proceed beyond submitting an NOI, nor is there a guarantee that your property will be selected for the program following evaluation. Upon evaluation, if a positive recommendation is given, the NOI and recommendation are reviewed by the County Manager and County Council.
