PUBLIC HEARING (Public Hearing comments are limited to 3 minutes) – **Fiscal Year 2027 Budget for Roy City Corporation**

- a. **Consideration of Resolution 26-24;** Consideration of proposed additional \$2,807,745 in property tax for employee wages and revenue shortfall and approval of A Resolution of the Roy City Council Adopting the Final Annual Budget for the Fiscal Year 2027 Commencing upon final approval from the Utah State Tax Commission and Ending June 30, 2027; and Setting the 2026 Certified Tax Rate.
- Roy City is considering a tax rate that exceeds the certified rate.
 - Roy City is considering increasing the certified tax rate to generate an additional \$2,807,745 of ad valorem tax revenue. The purpose of the increase is for:
 1. To balance the budget due to a revenue shortfall resulting from the Cost-of-Living Adjustment given to employees in March 2026.
 2. To give a 2.8% Cost-of-Living Adjustment to employees in the 2027 fiscal year and;
 3. To give wage correction adjustments to all full-time employees.
 - The proposed tax rate increase is approximately 54.94%.

Reduced for Fire Department Annexation, Roy Days Changes, SRO Contract & Property Tax New Growth

Roy City will consider an increase to its property tax rate from .001608 to .002159 to generate an additional \$1,751,100. The following information is intended to provide decision makers and the public with an explanation of the operational impact to each department if Roy City approves the proposed tax rate increase.

Impact of Tax Increase - This amount relates to a 2.5% COLA given to employees in March 2026. Since the 2025 property tax increase was denied, current revenues do not support these payroll expenses. With approval of the tax increase, the City would not need to draw from fund balance to balance the budget. This is an on-going expense so if the tax increase is not approved, the amount would draw from fund balance in each subsequent year. The Fire Dept has been removed from this amount.

RESOLUTION NO. 26-24

A Resolution of the Roy City Council Adopting the Final Annual Budget for the Fiscal Year Commencing July 1, 2026 and Ending June 30, 2027; and Setting the 2026 Certified Tax Rate.

Whereas, on June 16, 2026, the City Council adopted, by Resolution #26-17, the interim budget for the coming fiscal year, for purposes of further review, and set a public hearing for August 11, 2026 to consider final adoption of the budget; and

Whereas, the City of Roy has declared its intent to increase the certified tax rate; and

Whereas, the City has conformed to the truth in taxation requirements of the State of Utah through publication and posting of notices of the proposed property tax increase; and

Whereas, the Roy City Council on August 11, 2026, held a public hearing on adoption of said budget and to consider increasing the certified tax rate; and

Whereas, the Roy City Council has determined that the increase is necessary to fund wages, benefits and operating needs; and

Now, therefore, be it resolved by the Roy City Council, as follows:
