Approval of finances, Stacey Lyon finances look good. Zions Bank account has \$82,485.59 and the PTIF Account has \$51,011.98. Submitted for reimbursement for the CIB Grant for the full amount. Bills that need to be paid, Liability Insurance \$4,001.53 , reimbursing Ephraim City Brackets for new truck ruck \$1,206.00, Kimball & Roberts 2025 audit \$6,390.00, emailed audit report to all board members, Rocky Mountain Power \$3,415.00 and Wes Mangum for \$1,000.00 (which was approved last meeting) Motion to accept the finances- Jeff Cox Seconded by Scott Bartholomew.
