A person's domicile is the place where the person has established a fixed habitation and intends to remain indefinitely. Residency may be established through documentation reasonably acceptable to Payson City, including a driver's license, voter registration, property tax records, utility bills, or other evidence demonstrating domicile within Payson City."**
