A RESOLUTION ADOPTING THE TOQUERVILLE CITY FINAL BUDGET  
FOR FISCAL YEAR 2026-2027

RECITALS

WHEREAS pursuant to Utah Code 10-6-111, the City's Budget Officer prepared and submitted a Tentative Budget for Fiscal Year 2026-2027 to the City Council on May 6, 2026;

WHEREAS pursuant to Utah Code 59-2-924 (1)(s) and 59-2-924 (8)(a)(i), the City's Budget Officer prepared and submitted an Interim Budget for Fiscal Year 2026-2027 to the City Council on June 3, 2026;

WHEREAS in conjunction with the Tentative and Interim Budgets, the Property Tax Impact Schedule has been presented to the City Council as defined in Utah Code 59-2-924 (8)(b);

WHEREAS public hearings were duly noticed and held for the Tentative and Interim Budgets allowing residents to provide comments, as required by Utah Code 10-6-114;

WHEREAS a Truth in Taxation Hearing was duly noticed and held on August 11, 2026 for the proposed property tax increase, allowing residents to provide comments, as required by Utah Code 59-2-919;

WHEREAS the City Council has determined that the proposed Final Budget reflects the priorities and needs of the community and complies with all applicable legal requirements;

RESOLUTION

NOW THEREFORE, be it resolved by the City Council of Toquerville City, as follows:

The budget for Toquerville City for the Fiscal Year 2026-2027, as presented, is hereby adopted as the final budget for the City. The Budget Officer is directed to file a certified copy of the adopted budget with the State Auditor within 30 days, in accordance with Utah Code 10-6-118.
