#### **2. Grant Funding Discussion- The Ferguson Group (TFG)**

Council Member Steve Secrest discussed engaging The Ferguson Group as a joint partnership between the City Council and the Water Board to pursue funding opportunities, initially focusing on securing a second water source. Based on positive feedback from communities along the Wasatch Front, the firm has reportedly helped clients secure more than 50 million over the past four to five years.

The Ferguson Group would provide federal advocacy work with congressional offices and the Army Corps of Engineers and identify grant and earmark opportunities. The proposed annual advocacy fee is \$75,000.00, reflecting a 15% discount: grant-writing services would be an additional cost based on the size and complexity of individual applications.

The proposal will be placed on the next agenda for consideration and a vote by both governing bodies.
