On June 3rd, 2026, the City Council of Toquerville City adopted the following ordinances:

ORDINANCE 2026.13 AN ORDINANCE AMENDING THE TOQUERVILLE CITY OFFICIAL ZONING MAP FOR PARCEL T-149.

ORDINANCE 2026.14 AN ORDINANCE ADOPTING THE TOQUERVILLE CITY COMPENSATION SCHEDULE FOR FISCAL YEAR 2026-2027.

ORDINANCE 2026.17 AN ORDINANCE OF TOQUERVILLE CITY AMENDING TITLE 10, CHAPTER 19D, SECTION 12 OF THE TOQUERVILLE CITY CODE RELATED TO FENCING REGULATIONS AND PERMIT REQUIREMENTS.
