

REQUEST FOR COUNCIL ACTION

SUBJECT: Discussion and possible action establishing the Mayor's salary at the \$89,500 as outlined in the 2009 West Jordan Municipal Code 1-7B-4, and budgeted in Fiscal Year 2014-2015 Budget [Mayor Rolfe]

1-7B-4: COMPENSATION:

The mayor shall be paid an annual salary of up to a maximum of eighty nine thousand five hundred dollars (\$89,500.00); provided that the actual salary for any period of time may be determined by the mayor in a written notice to the finance director. This salary will be distributed to the mayor over twenty six (26) pay periods through the city's regular payroll system, including the withholding of state and federal taxes and state pension plan assessments. The mayor will not be required to submit time sheets. The mayor will also receive the standard benefits provided by the city to appointed officers of the city; provided that the mayor will be allocated no executive or compensatory leave.
