On April 30, 2015, Rocky Mountain Power, dba PacifiCorp (“PacifiCorp”) filed Advice No. 15-07, proposing revisions to Electric Service Schedule No. 37, Avoided Cost Purchases From Qualifying Facilities. On May 1, 2015, the Public Service Commission of Utah (“Commission”) issued a notice of filing and comment period requesting any interested party to submit comments on PacifiCorp’s proposed tariff revisions on or before Friday, May 15, 2015, and reply comments on or before Friday, May 22, 2015.

On May 13, 2015, Utah Clean Energy (“UCE”) filed comments in this docket requesting the Commission suspend the previously noticed comment and reply deadlines and hold a scheduling conference to establish additional time and process to address PacifiCorp’s proposed tariff revisions. UCE represents that it conferred with the Division of Public Utilities, the Office of Consumer Services and the Utah Association of Energy Users who all support UCE’s request for a scheduling conference.

Based on the foregoing and for other good cause showing, the previously noticed comment and reply deadlines are vacated. The Commission’s designated Presiding Officer will conduct a Scheduling Conference in this docket on **Tuesday, May 19, 2015, at 10:30 a.m. (MDT), Fourth Floor Room 401**, Heber M.
