NO ACTION COMMENTS

- 1. SCHEDULING.** The City Recorder informed those at the meeting of upcoming events, meetings, activities, etc.
- 2. CITIZEN COMMENTS/QUESTIONS.** None.
- 3. MAYOR COMMENTS.** Mayor Wood advised the Council that the City's Community Connection program has been recognized locally and nationally. Staffs from cities across the country have come to South Salt Lake to learn about this program and take it back to their communities.

- 5. **CITY COUNCIL COMMENTS.** Council Member Rutter reminded the citizens of the upcoming spring cleanup which will be a box, bundle, and bag program this year. He asked for their feedback on this program.

UNFINISHED COUNCIL BUSINESS

- 1. **An ordinance amending Chapter 3.16 – Disposal of Surplus Property, providing opportunity to donate surplus property to non-profit organizations pursuant to Section 10-8-2 of the Utah Code.** Deputy City Attorney, Paul Roberts, advised the Council on some of the costs that would be associated with this program. The software to wipe a hard drive costs about \$100 dollars. It takes about five hours to perform the process. It is estimated the City currently gets about \$1,000 dollars a year for computers sent to auction. The big question is still administering the program. There is noticing, receiving applications, making sure people are qualified to participate, having a wait list, and staff doesn't have an answer yet as to which department will be administering it or the cost to administer it. They don't have the staffing to do this currently. It may be a budget question, is this something they want to make sure is a priority?

NEW COUNCIL BUSINESS

- 1. **Animal Ordinance.** Mr. Roberts said he would like to add a little more to the definition of exotic animals, to exclude birds from it, and also put in the criteria that it must be over ten pounds and over three feet in length or height before it's considered an exotic animal. These would mostly be reptiles.

Mr. Roberts also pointed out the following changes in the proposed code:

- The new code also contains differences between a destruction order and a removal order. If someone has a problem animal, under the current code staff can only seek a destruction order. Staff’s intention is not to destroy the animal but remove them from that family and put them in a good home or rehabilitation center. Generally they will be seeking a removal order in most cases.
- They have also written in this new code a way to get before the administrative law judge quickly so the animals aren’t caged up for long periods.
- The animal cannot be adopted out of the shelter unless it is sterilized.
- If animals have been impounded a second time they must be sterilized.
- There would be special events where discounts on the adoption fee, or only pay the licensing fees, will be offered to adopt animals that the shelter has a surplus of.
- The biting/worrying section will be separated out. If someone has a bite with an injury it will be a Class B misdemeanor. A bite without injury will be a Class C misdemeanor. Chasing or worrying is an infraction.

To receive public input regarding proposed amendments to all 2014/2015 fund budgets. Finance Director, Kyle Kershaw, reminded the Council of the sick payout program. If there is extra funding identified in the first few months of the year the Mayor would recommend instituting the sick payout. The accrual year ended last Friday and staff got the balances and did the calculation on it. The total payout is about \$74,000 dollars which is about half of what it has been in prior years. For the payout staff sees a

need to amend the General Fund Budget by \$71,000. Staff is confident they will have revenue in the property tax line item.

- 3. **Amendment to the City’s land use ordinance and Zoning Map to remove density bonus language from the Municipal Code, and to amend development standards in the Transit-Oriented Development Overlay District and to establish a new zoning district called Transit-Oriented Development Overlay – Core.** Mr. Lilly continued the presentation from Item 2. This position is intended to encourage larger scale medium density residential development, where feasible, along the corridor. Last year the Council considered a development proposal for six townhome units at 3030 South that would fall under the TOD Overlay District and would not be in a core area and there were concerns expressed by both the Planning Commission and the City Council that the development did not have the scale to create a transformation from a commercial district to a residential district. So staff looked closely out how they could set the conditions that would actually transform a land use district. Those considerations went into the crafting of this ordinance proposal. This only addresses the Millcreek and Meadowbrook transit stations.
