

**TAYLORSVILLE, UTAH**  
**RESOLUTION NO. 15-10**

**A RESOLUTION ADOPTING A FINAL BUDGET  
FOR THE FISCAL YEAR BEGINNING JULY 1, 2015  
AND ENDING JUNE 30, 2016.**

**WHEREAS**, on May 6, 2015, the Budget Officer of the City of Taylorsville (the "City") submitted to the Taylorsville City Council (the "Council") a tentative budget including all supporting schedules and data (the "Tentative Budget") for the fiscal year beginning July 1, 2015, and ending June 30, 2016; and

**WHEREAS**, on May 6, 2015, the Council acknowledged and received the Tentative Budget and the Tentative Budget was officially placed in the City Recorder's office for inspection by the general public during normal office hours; and

**WHEREAS**, on May 10, 2015, notice of a public hearing to consider the Tentative Budget was published in the *Salt Lake Tribune* and the *Deseret News*; and

**WHEREAS**, on May 20, 2015, a public hearing to receive public comment and consider adoption of a final budget was held at 6:30 p.m. in the Council chambers located at 2600 West Taylorsville Boulevard, Taylorsville, Utah; and

**WHEREAS**, all interested persons in attendance at the public hearing were given an opportunity to be heard, for or against, the estimate of revenues and expenditures or any item thereof in the Tentative Budget; and

**WHEREAS**, the City has published the necessary notice and held the public hearing required prior to adopting the tentative budget; and

**WHEREAS**, it is the intent and desire of the City to comply with all applicable state and local laws regarding the adoption of the budget; and

**WHEREAS**, the Council finds that it has satisfied all legal requirements required to adopt a budget and that it is in the best interests of the citizens of the City to adopt a final budget for the City.

**NOW, THEREFORE, BE IT RESOLVED** by the Council as follows:

**Section 1. Budget Adoption.**

A. The Tentative Budget attached hereto, as amended, and incorporated herein by this reference, is hereby appropriated for the corporate purposes and objects of the City for the fiscal year commencing July 1, 2015, and ending June 30, 2016, and is hereby adopted as the "Budget of the City of Taylorsville, Utah for the Fiscal Year 2015-2016" (the "Budget").

B. Pursuant to UTAH CODE ANN. § 10-6-118, a copy of the Budget for each fund within the Budget shall be certified by the mayor as the budget officer and it is hereby directed that the Budget be filed with the State Auditor by June 30, 2015.

C. Pursuant to UTAH CODE ANN. § 10-6-118, a certified copy of the Budget shall be filed in the office of the City Recorder and shall be available for public inspection during regular business hours.

**Section 2. Further Action.**

A. In addition to the foregoing, the mayor is hereby directed to implement any other necessary actions pertinent to the adoption of the Budget. Such actions may include, but are not limited to, notification, reporting, and publishing as required by and consistent with applicable law.

B. Disbursements for the following budgeted line items shall only be made after review and authorized by the Council: Financial Audit and Studies.

C. Amounts budgeted for contingency, fund balance, and capital projects shall be deposited into the Public Treasurer's Investment Fund ("PTIF") for this specific purpose, with continuous regular amounts deposited throughout the fiscal year. Statements of these accounts shall be distributed to the Council on a monthly basis along with other expenditure reports.

**Section 4. Severability.** If a court of competent jurisdiction declares any provision of this resolution invalid, the remainder shall not be affected.

**THIS RESOLUTION**, assigned Resolution No. 15-10, shall take effect upon passage and posting as required by law.
