Cheri Mayer, Davis County Tax Administration, led the Pledge of Allegiance. All in attendance were invited to stand and join in.

Commissioner Millburn gave public notice of a special Commission Meeting tonight in connection with West Bountiful City Council Meeting at 7:30 pm, located at 550 North 800 West.

Sergeant Ellis Bruch, Davis County Sheriff’s Office, announced as of May 17th, the US Forest Service has closed Farmington Canyon temporarily due to the amount of water and slides they are experiencing in the Canyon. Currently, there are 45 active slides on the road in Farmington Canyon. Due to the events over the weekend, in which a car-sized boulder fell onto the road, they have decided to dynamite the other slides to help mitigate the danger presented by the slides. Commissioner Smith heard from the Sheriff that there were some families camping that were cut-off by the boulder. Ellis said there were 5 vehicles trapped above the boulder. The gate above, an egress to Bountiful, was still closed and is impassable. Davis County Public Works came and bulldozed the boulder off of the road. Once everyone was out of the canyon it was closed.

Adam Wright, Davis County Public Works Interim-Director, indicated that Robert Smith and Rocky Hamblin were the individuals who assisted in getting the boulder moved in Farmington Canyon. Robert, from the audience, described their procedure of moving the boulder.

Agreement #2015-225 with the Utah Department of Health to develop a supplemental public health emergency preparedness plan for Ebola. Brian explained they will also train health partners regarding Ebola preparedness. He indicated the plan will also assist with all emerging situations. Receivable amount is \$20,000.00. Period of contract is April 1, 2015 through September 30, 2016.

Commissioner Smith made a motion to approve. Commissioner Petroff seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Commissioner Millburn asked about the status of Ebola at the moment. Brian reported that Sierra Leone, Africa, has been cleared of any cases of Ebola. There have been no new Ebola cases reported in the U.S., and there is continued active monitoring of travelers.

Approval of 2 lot subdivision Moss Hollow Place and improvement agreement and grant of lien #2015-226

Jeff Oyler, Davis County Planning Department, presented request for approval of a two lot subdivision along with an improvement agreement and grant of lien #2015-226 for postponement of installation of public sidewalk improvements. The Moss Hollow Place Subdivision is located approximately at 1050 North in the unincorporated portion of Kaysville and is in a cul-de-sac. The lien is for the postponement of the installation of public sidewalk improvements on lots 1 and 2. Commissioner Millburn noted from reading the minutes of the Planning Commission Meeting that Davis County staff had recommended the contractor install the sidewalks while they were making improvements on the entire street. Jeff said the Planning Commission determined sidewalks were not necessary at this time. He said this is common in areas where there are no established sidewalks. If sidewalks are ever requested by the homeowners it will be their responsibility to pay for them according to the improvement agreement. The other two homes in the cul-de-sac were built in a private right-of-way. There is room for one more home to be built. All of the homeowners were in agreement not to have sidewalks. Commissioner Petroff understands the homeowners want to keep a country feel.

Commissioner Petroff made a motion to approve. Commissioner Smith seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Grant amendment #2013-555B UT Div of Emergency Management DR-1955 funding

Chief Deputy Kevin Fielding, Davis County Sheriff's Office, presented the following:

Grant amendment #2013-555B with Utah Division of Emergency Management for a funding increase of \$31,000.00 for the DR-1955 Hazard Mitigation Grant. The funding is to re-write the Pre-Disaster Mitigation Plan which will be addressed in the following agreement (#2015-227). Period of contract is August 1, 2013 through August 30, 2016.

Commissioner Smith made a motion to approve. Commissioner Petroff seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Agreement #2015-227 DeeEll Fifield consultation service Pre-Disaster Mitigation Plan

Agreement #2015-227 with DeeEll Fifield for consultation service to re-write the Pre-Disaster Mitigation Plan for Davis County. Mr. Fifield was the author of the original plan. Payable amount is service dependent of \$60/service hour up to \$31,000.00. Period of contract is from signing to September 30, 2016.

Commissioner Petroff made a motion to approve. Commissioner Smith seconded the motion. All voted aye. The document is on file in the office of the Davis County Clerk/Auditor.

Commissioner Millburn indicated the next item on the agenda, will be addressed as a Business/Action item of the Commission Meeting rather than as the Board of Equalization.

Minutes of 2015 Delinquent Property Tax Sale

Cheri Mayer, Davis County Tax Administration, presented a request to ratify the 2015 Davis County Delinquent Property Tax Sales, approve the associated minutes with the correction of Commissioner Millburn's name, and approve the Auditor's Tax Deeds of the 3 properties that were sold to be recorded. The sold properties were preferred sales. She indicated there were still interested buyers for some of the properties that were struck to the County. They have been instructed to work with Tony Thompson in the Davis County Planning Department. The associated minutes are as follows:

Cheri also explained that this is a buyers beware sale and that all sales are final, then conducted the sale on behalf of the Elected Clerk/Auditor Curtis Koch.

Notes: *Some properties may be identified as preferential sales. These are parcels that have been determined by the County to be sold without competitive bidding. These parcels are generally small and preference is given to the owner of the adjacent and abutting property. In many cases the parcel is already being used by the adjoining property owner.

*Some properties may be struck to the County for public purposes such as being part of a roadway, public easement or a detention basin, or property may be struck to the County due to no bid.

*Some properties may have been withdrawn from the sale. The reasons for withdrawal may be that the proper notice has not been given or erroneous legal descriptions, bankruptcy, duplicate assessments have been discovered or deferrals or settlements have been granted by the Davis County Commission.

Comments

Commissioner comments:

Commissioner Petroff encouraged everyone to turn off their sprinklers while Mother Nature continues to provide moisture. Doing so helps the water supply to last longer. He said you only need a half-inch a week to water a lawn. In his observation, most people are not watering and that they want to do the right thing. He indicated Weber Basin Water has been installing secondary water meters in new developments. They can then provide customers with a comparison report of their water consumption compared to their neighbors. Weber Basin has seen a 50% reduction in water use based on the meter even though a penalty is not imposed. He indicated, eventually all secondary systems (approx. 70,000) will have meters installed. Due to the cost of installing the meters (\$500-\$1000/meter) it will be done over a long period of time. He said that when people find out what they can do, they want to do the right thing, which is great to see even though there are no requirements or penalties.

Commissioner Smith hopes that Davis County sets the right example of not watering when it is raining. He challenged the new Facilities Director, Mack McDonald, who was in the audience, with the task.

Commissioner Millburn said Mack had recently sent him a report of what Facilities is doing to conserve. They are on top of it and making sure Davis County is setting the example.

Commissioner Smith also commented that this morning he toured the new Kaysville Branch Library and noted the grand opening is still on schedule for August 15, 2015. He said it is a tremendous facility and everyone is absolutely going to love it! He also commended the Library Board and thinks they are great!
