BOARD BUSINESS.....

MOTION TO APPROVE MINUTES FROM LAST MEETING CHRIS, MIKE SECONDS. UNANIMOUS. BOARD REELECTS NICK ROBERTS AS THE CHAIRMAN OF THE BOARD FOR 2014. MARCUS SWERS IN ALL APPEALING APPLICANTS AS WELL AS THE STATE.

AGENDA.....

JARED CHRISTENSEN- SCOTT STATES THAT MR CHRISTENSEN'S PERMIT WAS SUSPENDED BASED ON A PIA INVOLVING RETAIL THEFT. MR CHRISTENSEN THEN STATES THAT HE HAD GONE INTO A GROCERY STORE IN LOGAN TO PURCHASE ITEMS TO GO CAMPING. PICKED UP SOME BATTRIES AND PUT THEM INTO HIS POKET OF HIS JACKET BY ACCIDENT. PROCEEDED WITH HIS SHOPPING, PAID FOR THIS GROCERIES AND LEFT THE STORE. WALKING TO HIS CAR HE FELT IN HIS POCKET AND FOUND THE BATTRIES. WAS TURNING AROUND TO GO BACK INTO THE STORE WHEN SECURITY WAS APPROCHING HIM. WAS CHARGED WITH THEFT, DOES NOT DENY THIS CHARGE. MR CHRISTENSEN THEN STATES THAT HE HAD AN ATTORNEY, AND BOTH DECIDED ON THE PIA, THIS WAS THE LEAST EXPENSIVE OPTION. MOTION TO UPHOLD THE SUSPENSION UNTIL 4/24/14 CLARK, MIKE SECONDS. UNANIMOUS.

JESSE RICHMOND - JEFF STATES THAT MR RICHMOND'S PERMIT WAS DENIED BASED ON AN IMPAIRED DRIVING CONVICTION IN 2011. MR RICHMOND THEN STATES THAT IT WAS A VERY STUPID MISTAKE, IS NOT GOING TO DENY IT. HAD BEEN OUT IN THE WEST DESERT SHOOTING EARLIER IN THE DAY, DECIDED TO STAY AND HAVE A FIRE WITH SOME FRIENDS. MR RICHMOND THEN INDICATES THAT HE HAD DROVE SOME FRINEDS DOWN TO THE MAIN ROAD TO GET THEIR CAR, WAS ON HIS WAY BACK TO THE CAMPFIRE WHEN A SHERIFF STOPED HIM. HAD THE CHARGE DROPED FROM A DUI TO A IMPAIRED DRIVING. BAC WAS .12 AT THE TIME OF HIS ARREST. INFORMS BOARD THAT HE HAS QUIT DRINKING SINCE THE INCIDENT. MOTION TO UPHOLD THE STATE CHRIS, MIKE SECONDS. UNANIMOUS.

DAVID CRAVEN- JEFF STATES THAT MR CRAVEN'S PERMIT WAS ORIGINALY SUSPENDED BASED ON A 2013 PENDING FELONY CHARGE OF WRONGFUL

APPOPRIATION. IN AUG OF 2013 MR CRAVEN WAS FOUND GUILTY OF A CLASS B MISD OF WRONGFUL APPOPRIATION, THIS IN TURN RESULTED IN THE REVOCATION OF MR CRAVEN'S PERMIT. MR CRAVEN THEN READS FOR THE BOARD HIS STATEMENT ON HIS CHARGE. INFORMS BOARD THAT HIS MOTHER HAD PASSED AWAY A FEW MONTHS PRIOR TO ALL THIS STARTING. WAS ON HER BANK ACCOUT, CHECKING ECT. DID NOT KNOW THAT SHE WAS RECEIVING SOCIAL SECURITY DEPOSITS, AT THE TIME OF HER PASSING. WAS CONTACTED BY THE US GOVERNMENT CONCERNING THIS ACCOUNT. MR CRAVEN CLAIMS THAT HE NEVER AT ANYTIME TOOK ANY MONIES FROM THIS ACCOUNT. DECIDED TO PLEA TO A CLASS B AND PAY RESTITUTION IF THEY DID NOT INVOLVE HIS WIFE. MR CRAVEN'S ATTORNEY THEN STATES THAT WRONGFUL APPOPRIATION IS DIFFERENT THAN THEFT, A FELONY CHARGE PLED DOWN TO A CLASS B IS VERY RARE. MR CRAVEN'S WIFE THEN SPEAKS ON HIS BEHALF. STATES TO BOARD THAT SHE WAS TAKING CARE OF ALL HIS MOTHERS BILLS AND USING MONEY OUT OF THAT ACCOUNT TO DO SO. SHE CLAIMS THAT SHE DID NOT KNOW ABOUT THE DEPOSITS FROM THE SS EITHER. NICK MOTIONS TO UPHOLD PENDING THE DATE OF LICENSE EXPIRATION, 1 YEAR OF SUSPENSION FROM 9/25/15, CLARK SECONDS. UNANIMOUS.

CARL HANSEN-JEFF STATES THAT MR HANSEN'S PERMIT WAS REVOKED BASED ON A 2012 IMPAIRED DRIVING CONVICTION. MR HANSEN THEN STATES THAT 2012 WAS A VERY ROUGH YEAR FOR HIM. MR HANSEN INDICATES THAT HE HAD BEEN IN WENDOVER THE NIGHT BEFORE DRINKING PRETTY HEAVELY. HAD A FREE ROOM, WENT AND SLPT FOR TWO HOURS WOKE UP AND FELT LIKE HE WAS FINE TO DRIVE HOME. WAS PULLED OVER ON THE UTAH SIDE AND CHARGED WITH A DUI. THIS CHARGE WAS PLED DOWN TO AN IMPARED DRIVING. MR HANSEN'S BAC WAS .28 AT THE TIME OF HIS ARREST. INDICATES THAT HE WAS WORING TOWARDS BECOMING A NRA AND STATE OF UTAH FIREARM INSTRUCTOR. DID NOT LOOSE HIS CDL. MR HANSEN WOULD LIKE TO APPOLIGIZE TO BOARD FOR WHAT HE HAS DONE. MOTION TO UPHOLD THE STATE MIKE, CLARK SECONDS. UNANIMOUS.

BENJAMIN ROLLINS- PHIL STATES THAT MR ROLLINS'S PERMIT WAS DENIED BASED ON A 2009 DRIVING WHILE IMPARIED CONVICTION, WITH A 5 YEAR PROBATION PERIOD. MR ROLLINS THEN STATES THAT THE CONVICTION WAS DELAYED FOR A YEAR DUE TO BEING IN THE MILITARY. MR ROLLINS THEN STAES THAT HE DID NOT SUBMIT THE SR22 FORM TO THE INSURANCE COMPANY LIKE HE WAS TOLD TO DO. THIS RUSULTED IN A 5 YEAR PROBATION. INFORMS BOARD THAT HE HAD BEEN DEPLOYED SEVERAL TIMES AND WAS SUFFERING THE AFFECTS OF THIS. CLAIMS THAT HE LOST FRIENDS AND WAS SELF MEDICATING WITH ALCOHOL. INDICATES THAT HE HAD GONE TO THE VA FOR HELP DEALING WITH HIS ISSUES, DOES NOT DRINK ANY LONGER. NICK MOTIONS

TO UPHOLD TO THE DATE OF 3/18/14, MIKE SECONDS. UNANIMOUS.

KIMBERLY ELMORE- PHIL STATES THAT MS ELMORE'S PERMIT WAS DENIED BASED ON A 2007 FELONY CONVICTION OF RAPE OF CHILD AS A JUVENILE. THIS A VIOLENT JUVENILE CONVICTION WHICH HOLDS A 10 NON ELIGIBILITY. BOARD INFORMS MS ELMORE THAT THEY DO NOT WANT HER TO GO INTO HER LETTER SHE PROVIDED FOR THE APPEAL, THEY ARE AWARE OF THE CHARGES. MS ELMORE THEN STATES THAT SHE APPEALED THIS DENIAL BECAUSE SHE IS AFRAID FOR HER AND HER TWO CHILDREN. SHE THEN STATES THAT SHE IS BEING THREATENED BY HER EX-HUSBAND, HE IS GOING TO KILL HER. DOES NOT HAVE AN ACTIVE PO AT THIS TIME. CLARK MOTIONS TO OVERTURN THE STATE, MOTION WITHDRAWN. AG'S OFFICE INFORMS BOARD MS ELMORE IS NOT ELIGIBLE BY STATE AND FEDERAL LAW WITH THIS CONVICTION. MOTION TO UPHOLD NICK, MIKE SECONDS. UNANIMOUS. INFORMS MS ELMORE THAT SHE HAS OTHER OPTIONS AT THIS TIME, CAN REAPPLY IN 2017.

BRADLEY HILL- IN ABSENTIA CHRIS MOTIONS TO UPHOLD THE STATE, MIKE SECONDS. UNANIMOUS. UPHELD.

ROBERT ZALDIVAR- IN ABSENTIA CHRIS MOTIONS TO UPHOLD THE STATE, CLARK SECONDS. UNANIMOUS. UPHELD.

RICHARD D'IPPOLITO- IN ABSENTIA NICK MOTIONS TO UPHOLD THE STATE, CLARK SECONDS. UNANIMOUS. UPHELD.
