Welcome

- Steve Ketter calls meeting to order as David Brown isn't at the meeting. The board schedules the next two board meetings:
 - Wednesday April 22 at 8:30 am
 - Wednesday July 22 at 8:30 am

- Steve Ketter motions to accept those dates, Chief Shepherd seconds and all are in favor
- The board moves on to select a chairman and a co-chair. Chief Shepherd motions to elect Steve Ketter as the board chairman, Don DeLaMare seconds and all are in favor.
- David Brown enters meeting
- Steve Ketter motions to elect Don DeLaMare as co-chair of the board, Chief Shepherd seconds and all are in favor.
- Steve Ketter asks to stop the meeting and recorder so that David Brown may look through the applications.
- Steve Ketter brings the meeting back once David Brown has looked at all 6 applications
- Steve Ketter motions to approve the minutes from the October minutes, David Brown seconds and all are in favor
- The board moves on to applications: Steve Ketter talks about how each application looks complete. He asks the board if there is anything they would like to discuss with a particular license. The board agrees that they would like to approve each license as a group under the type of license.

Apprentices

- The board moves on to suspensions

Suspensions

1. Michael Bonin: Jeff Dunn, BCI, presents to the board his appeal for suspension for Mr. Bonin due to the fact that Mr. Bonin had his sponsorship revoked. Because Mr. Bonin doesn't currently have a sponsor, he is no longer eligible to have a valid license. BCI has sent a letter to Mr. Bonin and has talked to him many times about the issue and what can be done. Steve Ketter lets the board know that he was Mr. Bonin's sponsor and he revoked that sponsorship due to the fact that Mr. Bonin is no longer working for the company Steve Ketter was willing to sponsor some people for. Steve Ketter motions to suspend Mr. Bonin's license based on the revocation of sponsorship, Chief Shepherd seconds and all are in favor of the suspension. BCI asks for clarification as to what Mr. Bonin will be required by the board to become reinstated. The board talks about giving BCI the authority to reinstate Mr. Bonin's

license if a letter of sponsorship is received for him. Steve Ketter makes a second motion allowing BCI to reinstate Mr. Bonin's license if BCI has received a new letter of sponsorship for him. David Brown seconds and all are in favor. Mr. Bonin's license is suspended, and BCI has the authority to reinstate that license if a letter of sponsorship is received.

- Steve Ketter motions to adjourn the meeting until April, Chief Shepherd seconds and all are in favor.
