**A RESOLUTION TO APPROVE AN INCREASE IN ANIMAL CONTROL FEES TO OFFSET FEE INCREASE BY THE CACHE HUMANE SOCIETY**

**WHEREAS**, the Logan City Police Department provides animal control services to Logan City residents, and as part of these services, it is necessary at times to impound animals, and euthanize animals; and

**WHEREAS**, the Cache Humane Society is the contract group for impound, boarding and euthanizing of said animals; and

**WHEREAS**, it is projected that the Cache Humane Society will increase its fees as outlined herein beginning July 1, 2015. In keeping with the additional fees charged to the Logan City Police Department by the Cache Humane Society, the Logan City Police Department seeks to increase fees equal to that of the Cache Humane Society.

**NOW THEREFORE, BE IT RESOLVED THAT THE LOGAN MUNICIPAL COUNCIL** that the fees for certain animal control services be increased as detailed in the animal control fee increase schedule attached hereto.
