MOTION TO APPROVE MINUTES FROM LAST MEETING, ROBERTS, APOSHIAN SECONDS. UNANIMOUS.

MARCUS WITH THE AG'S OFFICE SWEARS IN OFFICERS AS WELL AS ALL APPEALING APPLICANTS.

JARED NUSSMAN- MR NUSSMAN'S PERMIT WAS DENIED BASED ON A 2012 PURCHASE, POSSESS, CONSUME ALCOHOL BY MINOR CONVICTION, CLASS B. MR NUSSMAN THEN STATES THAT HE HAD JUST RECENTLY MOVED TO UTAH FROM VIRGINIA, MILITARY MOVE, WAS ASKED IF HE WOULD LIKE TO GO TO A PARTY WITH SOME PEOPLE HE WORKED WITH. MR NUSSMAN THEN STATES THAT ONCE THEY ARRIVED AT THE PARTY HE HAD ABOUT A HALF OF A BEER, BECAUSE HE WAS UNDERAGE. THEY THEN LEFT THE PARTY AND PULLED OVER. THE DRIVER AND FOUR OTHER PEOPLE IN THE CAR HAD NOT BEEN DRINKING. WHEN ASKED IF HE HAD, HE TOLD THE OFFICER THAT HE HAD ABOUT A HALF OF A BEER. DUE TO HIS MILITARY BACKGROUND, HE COULD NOT LIE TO THE OFFICER. MR NUSSMAN ATTENDS UVU AND IS GOING FOR HIS CRIMINAL JUSTICE DEGREE. CLAIMS THAT HE IS A SINGLE DAD AND WOULD LIKE TO HAVE THE PERMIT TO PROTECT HIMSELF AS WELL AS HIS SON. MOTION IS TO HAVE MR NUSSMAN MAKE NEW APPLICATION IN 6 MONTHS (DEC) AND THE STATE WILL THEN GRANT HIM HIS PERMIT KOORKING, LICHTENBERG SECONDS. THE CLASS DOES NOT NEED TO BE RETAKEN. APOSHIAN VOTES NAY. OVERTURNED.

DAVID RICCI -MR RICCI PERMIT WAS DENIED BASED ON A 1982 FELONY CONVICTION. MR RICCI THEN STATES THAT HE WAS ISSUED A NEW YORK STATE PERMIT IN 2011 AS WELL AS APPLIED AND RECEIVED A PERMIT FROM THE STATE OF FL. MR RICCI CURRENTLY HOLDS A VALID HUNTING LICENSE FOR THE STATE OF NEW YORK. A FULL RELIEF WAS ISSUED FROM THE STATE OF NEW YORK. MR RICCI WOULD JUST LIKE THE STATE OF UTAH TO REREVIEW HIS CASE. HE HAS DONE A LOT OF RESEARCH ON THE UTAH LAW. MOTION TO OVERTURN THE STATE APOSHIAN ACCEPT APPLICATION AS IS, LOYD SECONDS. OVERTURNED. ROBERTS ABSTAINS FROM VOTE.

YVAN VELAZQUEZ- MR VELAZQUEZ PERMIT WAS DENIED BASED ON A NICS DENIAL MENTAL. MR VELAZQUEZ THEN STATES THAT HE JOINED THE ARMY IN 2006, WENT TO IRAQ IN 2007. SERVED ABOUT A YEAR IN IRAQ, CAME HOME AND THEN BEGAN PREPARING TO RETURN TO IRAQ. AT THIS TIME HE WAS SUFFERING FROM SOME BACK AND ANKLE PAIN. MR VELAZQUEZ WEN TO THE EMERCENY ROOM TO HAVE THESE CHECK, AT THAT POINT HE SUFFERED SOME

PTSD. THE VETERENS ASSOCIATION HAS MARKED HIS STATES AS MENTALLY INCOMPTANT. MOTION TO UPOLD THE STATE ROBERTS FOR THE TIME BEING. BOARD SUGESTS THAT MR VELAZQUEZ CONTCT VETERN AFFARIS TO HAVE THIS FLAG REMOVED, KOORING SECONDS. NO CLASS REQUIRED IF CHARGE HAS BEEN REMOVED WITHIN ONE YEAR OF CLASS. UNANIMOUS.

SHAWN CONDER- MR CONDERS PERMIT WAS REVOKED BASED ON A 1983 FELONY CONVICTION FOR THEFT. MR CONDER THEN STATES THAT HE HAD TWO CHARGES FOR THEFT, BUT THEY WERE DROPED TO MISD. CLAIMS THAT HE CONTACTED THE COURT, AND THEY INFORMED HIM THAT THERE WAS A MISTAKE IN THE SYSTEM. COULD NOT FIND THE FELONY CONVICTION. MOTION TO UPHOLD THE STATE ROBERTS, APOSHIAN SECONDS. BOARD DOES INDICATE THAT IF THE CHARGE IS FIXED AND UPDATED TO REFELCT MISD CONVICTION, THE BOARD WILL THEN OVERTURN. UNANIMOUS. UPHELD.

SAMUEL WORLEY- MR WORLEY'S PERMIT WAS DENIED BASED ON 2014 CRIMINAL MISCHIEF CONVICTION CLASS B. MR WORLEY THEN STATES THAT HE WAS RIDING HIS BMX BIKE ON THE BYU CAMPUS. WHILE THERE HE WAS DOING TRICKS ON THE BIKE LIKE RIDING ON THE HAND RAILS. MR WORLEY WAS CITED FOR CRIMINAL MISCHIEF BY BYU PD. DOES NOT FEEL LIKE THIS IS A FAIR CHARGE. MOTION TO UPHOLD THE STATE APOSHIAN, LOYD SECONDS. UNANIMOUS. UPHELD.

BIRAN GODFREY- IN ABSENTIA LOYD MOTIONS TO UPHOLD THE STATE, KOORING SECONDS. UNANIMOUS. UPHELD.
