**RESOLUTION APPROVING THE REALLOCATION OF
FY 2014-2015 and FY 2015-2016
CDBG FUNDS
FOR
LAND PURCHASE AT THE TAYLORSVILLE SENIOR CENTER
AND AMENDING THE ONE YEAR CDBG ACTION PLAN
FOR FY 2015-2016**

WHEREAS, the City of Taylorsville will reprogram funds not disbursed in the FY 2014-2015 CDBG Program. These funds will be reprogrammed from Wasatch Front Regional Council, Sidewalk Replacement Various Locations and the Senior Center Improvements. The amount to be recaptured is \$180,469. These funds will be reprogrammed to purchase land south of the Taylorsville Senior Center.

WHEREAS, the City of Taylorsville will reprogram 2015-2016 funds from the Senior Center Building. The amount to be reprogrammed is \$139,179.

WHEREAS, it is in the best interest of the people of Taylorsville that the City reprogram these funds to better serve the needs of the community; and

WHEREAS, the public notices, hearings and other requirements as set forth in 24 CFR Part 91 have been accomplished by the City, including but not limited to the following: A public hearing held Wednesday, August 5, 2015 to consider amending the plan and to obtain views of citizens.

WHEREAS, the City Council does meet now this Wednesday August 5, 2015 to approve the reprogramming of \$319,648 in CDBG funds and Amend the 2015-2016 CDBG One Year Action Plan.

NOW, THEREFORE, be it resolved by the City Council of Taylorsville, Utah as follows:

1. That the Mayor, as the official representative of Taylorsville, is hereby authorized to amend the City's 2015-2016 CDBG One Year Action Plan and sign any required documents.
